The above entitled action having come on for trial, upon the issues made by the application of the petitioners herein, A. J. Myrland, Esq. appearing for the petitioners, and no one appearing in opposition to the organization of a town as prayed for in the application, and having been tried by the court without a jury, and the court having heard the testimony of the witnesses for the petitioners, and the testimony of the witnesses for the opponents, and the arguments of counsel, and having been advised in the premises, I, the judge before whom the same was tried, do find as

Findings of Facts

That township thirty nine, north, range nineteen, west, township thirty nine, north, range eighteen, west, township forty, north, range eighteen, west, and township forty, north, range nineteen, west, is contiguous territory, within Burnett County, and contains more than a government township, and is a part of the town of Marshland, said county.

That said territory has more than fifty resident electors and an assessed valuation of more than one hundred thousand dollars, according to the last preceding assessment.

That the verified petition presented to this court, at a regular term of the Circuit Court of Douglas County, the same being a special term for Burnett

County, begun and held at the court house in the city of Superior, Douglas county, on the 6th day of February, 1906, praying for an order of this court to organize the said territory into a new town, to be known as the town of West Marshland, was signed by a majority of the resident freeholders and ~~resident~~ homesteaders, and by a majority of the resident electors residing in said territory.

That such petition accurately described such territory, and named the town of which it is a part, and contained the names of the resident electors, the assessed valuation of such territory, the proposed name of the new town, and was verified by three signers of said petition.

That the remaining territory in the town of Marshland is not less than a government township.

That all the facts set forth in the petition aforesaid are true, and all the requirements of Sections 775a, 775b and 775c, of the <sup>of Wisconsin</sup> statutes of 1898, also known as Chap. 21, laws of 1905, have been complied with.

And I find as

#### Conclusions of Law

That the petitioners are entitled to an order creating said territory into a town to be named West Marshland.

Now, therefore, upon motion of A. J. Myrland, attorney for petitioners,

#### IT IS ORDERED

That township thirty nine, north, range eighteen, west, township thirty nine, north, range nineteen, west, township forty, north, range eighteen, west, and township forty, north, range nineteen, west, be and the same is hereby created into a new town to be called the town of West Marshland, Burnett County, Wisconsin, and that the first annual meeting of the electors of said town of West Marshland shall be held at the Freya school house, in sec. 35, Twp. 39, N.R. 18.W.
