

Dear Sir:

We wish to acknowledge receipt of the corrective ordinance creating the Town of Wagner and which you certified to on December 27, 1916.

We beg to call your attention to the fact that the document does not show the date on which this corrected ordinance was passed. Will you kindly insert this important imformation?

Permit us again to call your attention to the importance of securing the passage of a legalizing act by the next legislature to set at rest forever the legality of the acts of this new town board prior to the time when Township Thirty-three North of Range Twenty-two was legally included. Questions as to the legality of roads laid out, school districts organized, etc., may be raised in the future to annoy you.

We suggest that you call the attention of your district attorney to this matter. But please allow us to assure you that we make this suggestion only in the spirit of friendly helpfulness and because we desire to aid you in avoiding complications which might arise in the future.

The ordinance is returned to you herewith.

WHEREAS. The Town of porterfield at its last annual meeting on April 7th. 1914, voted upon town division: namely to create the new town of Wagner out of the northern half of the old town of porterfield to contain the territory as described below, and WHEREAS, The vote carried in both proposed suv-division of said town and that each sub-division contains more than thirty-six sections of land valued at the last preceding assessment at more than \$ 100,000.00, and has more than 50 qualified voters resident therein, and contains a population of more than 125 inhabitants, therefore, BE IT RESOLVED: - 1st. That in accordance with the powers granted County Boards under Section 671 of the Revised Statutes of Wisconsin, the request of the petitioner of the Town of Porterfield be granted, And that Sections one to twelve both inclusive of township thirty two north of range twenty-two East, and all of fractional township thirtythree north of range twenty-three East, and fractional township thirty four north of range twenty-two East and fractional township thirty-four north of range twenty-three East, being part of the present town of Porterfield. are hereby set off and detached from said town and created and constituted a seperate town to be known and designated as the town of Wagner. To take effect after the first meeting of said Town. NO. 2.- Jospeh Wagner Sr., S.O. Peterson and John E. Johnson are hereby named as Caucus Committee for said Town of Wagner who shall post notices for the first Town Caucus for said Town as provided for in Chapter 686 of Laws of Wisconsin for 1913. Said first Caucus to be held at Wagner school house in School District No. 4 of said Town on the 26th day of March, 1915, 2:30 o ' clock afternoon, provided further that John E .-Johnson of said caucus committee is hereby appointed to receive and file all nomination papers for the nomination of candidates for the first town meeting for the said new Town of Wagner and he shall cause to be printed a sufficient number of sample and official ballots, as per nominations made at said caucus and by nomination papers filed with him at the expense of the new Town of Wagner, and deliver same to the Election Inspectors of said new Town of Wagner at 9 a.m. the morning of the first town meeting. No. 3. The first town meeting of said townof Wagner shall be held at the school house known as Wagner School in School District No. Four of said town on the first Tuesday of April, 1915 and at such meeting the qualified electors of said town shall in the manner provided by law, elect town officers for said town, and any and all business that may properly come before the electors of any duly organized town have the power to do. For the purpose of such town election, the qualified electors of said town, assembled at the place aforesaid; shall between the hours of nine and eleven o clock in the forenoon of said day choose three their number to act as inspectors and two to act as ballot clerks of the election and one to act as town clerk, and such inspectors, ballot clerks

severally take the usual oath of office and file the same with their returns, and such inspectors and town clerks shall respectively canvass and return the vote cast at such election in all respects as provided by law for inspectors and town clerks at Annual Town Meetings. NO. 4 Notice of said first town meeting shall be given by the posting of notices thereof in at least five public places in said town at least ten days before the time of holding said first town meeting by the town clerk of the town of Porterfield, who shall make a proper affidavit of such posting and file the same the day of the first town meeting with the Inspectors chosen at said meeting to conduct the same. NO. 5 When said town meeting shall have been held as herein provided and the town officers required by law duly elected and qualified. the said town of Wagner shall be deemed to be duly organized, and shall possess all the rights, powers and liabilities of other towns in the county. NO. 6 The assets and liabilities of said towns of Wagner and Porterfield shall be apportioned to the said town of Wagner pro rata in proportion as the valuation of all the taxable property detached from the said town of Porterfield bears to the whole of the assessed valuation of said town according to the assessment roll for the year 1914. The Supervisors of the town of Porterfield and the Supervisors of the new Town of Wagner, shall on the first Monday in May 1915, meet at the office of the town clerk of the town of Porterfield for the purpose of making a settlement between said two towns according to the provisions of section 672 of Statutes, and at said meeting any three of the Supervisors shall have full power and authority to send for and have brought before them at such meeting any books, papers and records necessarily involved or needed in the settlement between the two towns. The Town Clerk of the town of Porterfield shall act as clerk of said meeting, and the clerk of the new town of wagner shall be present and assist as such clerk and sufficient duplicates or copies of all proceedings shall be made in order that each town shall have at least one for the use and information of the Town Clerk and Town Board of Supervisors thereof. Each town shall be chargeable with the expenses and for the services of its own officers only, and the bills thereof shall be audited and paid by the respective towns of Wagner and Porterfield as other bills are by law authorized to be audited and paid. J.O. ROLLINS C.A. CORRELL The roll was then called upon the proposed town division resulting in all voting Aye except Supervisor Anderson, Kleinprintz, Miller and Strehlau, absent.
