The Board of Supervisors of Oconto Co. do order & determine as follows:

That the boundaries of the Towns in said County shall be as follows, to wit:

- 1<sup>st</sup> The Town of Little Swamies shall embrace Township 26, of Ranges 19. 20. & 21, and all of Ranges 11 & 12 in Oconto Co. South of Township 38.
- 2<sup>nd</sup> The Town of Pensaukee shall embrace Townships 27, Ranges 19. 20. 21. & 22, and all of Ranges 13 & 14 in Oconto Co. South of Township 38.
- 3<sup>rd</sup> That the Town of Gillett shall embrace Township 28, Ranges 18 & 19  
Townships 29 " 18  
" 30 " 18, and all of Range 15 in Oconto Co. South of Township 38. And that the first Town Meeting be held at the School house in Dist No. 3. as at present districted.
- 4<sup>th</sup> The Town of Stiles shall embrace Township 28, Range 20, and all of Ranges 16. & 17 in Oconto Co. South of Township 35.
- 5<sup>th</sup> That the Town of Oconto shall embrace Township 28, Range 21, excepting Lot 1 in Section 24, and all of Township 28, Range 22, excepting Sections 19. & 20.
