

PARCEL 1: Land in Certified Survey Map NO. 2830, is recorded in Volume 11 of CSM's, Page 135 as Document NO. 319973; being Lots 12, 13, and 14 also a part of lots 26 and 27 of Assessor's Plat of Government Lots 1 and 2 in Section 12, Township 19 North, Range 8, East, Waushara County, Wisconsin.

PARCEL 2: Lot 1 of Certified Survey Map NO. 3580, recorded in Volume 15 of CSM's, PAGE 283 as Document NO. 343326, Waushara County Registry, being part of the Assessor's Plat of Government Lots 1 and 2 in Section 12, Township 19 North, Range 8 East, Waushara County Wisconsin.

PARCEL 3: LOT 15 OF Assessor's Plat of Government Lots 1 and 2 in Section 12, Township 19 North, Range 8 East, according to the recording to the recorded plat there of, also following described piece or parcel of land in Lot 26 of said Assessors Plat of Government Lots 1 and 2 in Section 12, Township, 19 North, Range 8 East. Commencing at the NE corner of Lot 16 in said Assessors Plat; thence North to the S'ly line of the highway known as Hancock and Wautoma road; thence SE'ly direction along the S'ly boundary line of said highway 50 ft.; thence S.; to the NE corner of said Lot # 15; thence in a NW'ly direction along the N. line of said Lot # 15 a distance of 50 ft. to the place of beginning; as set forth in Exhibit A hereto, a certified copy of said Ordinance #1998-1.

ORDINANCE NO. 1998-1

ORDINANCE ATTACHING TERRITORY TO THE TOWN OF HANCOCK WAUSHARA COUNTY, WISCONSIN

The Town Board of the Township of Hancock, Waushara County, ordains as follows:


Section I. In accordance with Section 66.022 of the Wisconsin Statutes, and receiving the Village of Hancock's Ordinance for detaching the following described territory from the Secretary of State's office; February 10, 1998, and the said territory therein described is contiguous to the Town of Hancock, Wasushara County, Wisconsin; the following described territory of the Village of Hancock, Waushara County, Wisconsin, becomes part of the Town of Hancock, Waushara County, Wisconsin:

PARCEL 1: Land in Certified Survey Map NO. 2830, recorded in Volume 11 of CSM's, Page 135 as Document No. 319973; being Lots 12, 13, and 14 also a part of Lots 26 and 27 of Assessor's Plat of Government Lots 1 and 2 in Section 12, Township 19 North, Range 8 East, Waushara County, Wiscosnin.

PARCEL 2: Lot 1 of Certified Survey Map NO. 3580, recorded in Volume 15 of CSM's, page 283 as Document NO. 343326, Waushara County Registry, being part of the Assessor's Plat of Government Lots 1 and 2 in Section 12, Township 19 North, Range 8 East, Waushara County, Wisconsin.

PARCEL 3: Lot 15 of the Assessor's Plat of Govt. Lots 1 and 2 in Section 12, TWp. 19 N., R. 8 E., according to the recorded plat thereof, also the following described piece or parcel of land in Lot 26 of said Assessors Plat of Govt. Lots 1 and 2 in Sec. 12, Twp. 19 N., R.8 E.: Commencing at the NE corner of Lot 16 in said assessors Plat; thence N. to the S'ly line of the highway known as Hancock and Wautoma road; thence in the SE'ly direction along the S'ly boundary line of said highway 50 ft.; thence S. to the NE corner of said Lot #15; thence in a NW'ly direction along the N. line of said Lot #15 a distance of 50 ft. to the place of beginning.

Section II. From and after effective date of this ordinance, the territory described in Section I hereof shall be a part of the Town of Hancock, Waushara county, Wisconsin, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Town of Hancock.



Section III. If any of the provisions of ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.

Section IV. This ordinance shall take effect upon passage and publication as provided by law.

Duly and regularly adopted by an affirmative vote of more than two-thirds of the elected members of the Town Board of the Town of Hancock held on the 9th day of March, 1998.
