ORDINANCE

AN ORDINANCE TO ANNEX THE LAKE MARION PARK PROPERTY TO THE VILLAGE OF MAZOMANIE

WHEREAS the following described property, commonly referred to as the Lake Marion Park Property, is owned by the Village of Mazomanie pursuant to a quit claim deed from the State of Wisconsin Department of Natural Resources dated August 3, 1984, recorded in the office of the Register of Deeds for Dane County, Wisconsin in Volume 5998 of Records, Page 74, Document No. 1847327;

AND WHEREAS the following described property is under the control of the Village of Mazomanie and operating as a public park;

AND WHEREAS the following described property is presently located in the Town of Mazomanie, Dane County, Wisconsin, and is contiguous with the Village of Mazomanie, Dane County, Wisconsin,

THEREFORE, be it ordained by the Village Board of the Village of Mazomanie that, pursuant to Wisconsin Statute Sec. 66.025, the following described property is hereby annexed to and made a part of the Village of Mazomanie, Dane County, Wisconsin, and be detached from the Town of Mazomanie, Dane County, Wisconsin. Such annexed territory is described as follows:

Dane County, State of Wisconsin:

T8N, R6E

Section 16: All that part of the SE 1/4, the SW 1/4 of the NE 1/4 and the SE 1/4 of the NW 1/4 described as lying southwesterly of the Chicago, Milwaukee, St. Paul and Pacific Railroad, south of U. S. Highway 14 northeasterly of County Trunk KP and north of a line described as: Commencing at the southeast corner of Section 16, thence North along the east line of said Section 311 feet to said Railroad Right-of-way, thence west 575 feet, thence N49°W 355 feet, thence N23°W 156 feet thence N88°30'W 300 feet thence S56°45'W78' to County Trunk KP and the end of said line. Intending to convey all lands described in V.700-P.163, V.719-P.585, V.695-P.286, V.587-P.388 as recorded in Dane County Register of Deeds including any land or water or flowage right that may lie in Section 15, 8N, 6E.

BE IT FURTHER ORDAINED that upon annexation and attachment to the Village of Mazomanie, the above described property shall, for all purposes, be zoned a conservancy district as defined in the zoning code, Chapter 10, of the Municipal Code of the Village of Mazomanie, Wisconsin.
