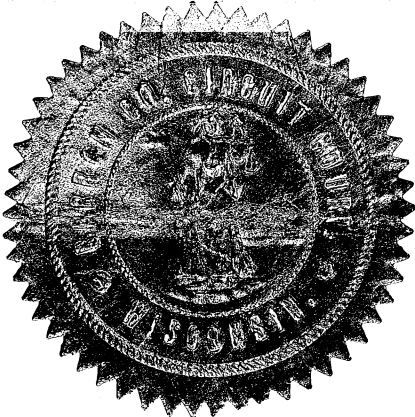

to is described as follows:- Commencing at the quarter post between section 32 & 33, Township 32 of Range 13 in Barron County, Wisconsin running thence north on the section line 10560 feet to the quarter post between sections 20 & 21; thence west on the quarter line 2614 feet to the center of section 20, thence north on the quarter line 2640 feet to the North  $\frac{1}{4}$  post between sections 17 & 20; thence east on the section line 5252 feet to the quarter post between sections 16 & 21; thence north on the quarter line 3960 feet to the north west corner of the S.W. $\frac{1}{4}$  of the N.E. $\frac{1}{4}$  of section 16, thence east on the  $\frac{1}{8}$  line 2654 feet to the N.E. corner of the S.E.  $\frac{1}{4}$  of the N.E. $\frac{1}{4}$  of section 16; thence south on the section line 3960 feet to the corner of sections 15, 16, 21 & 22; thence east 3923 feet to the north east corner of the N.W. $\frac{1}{4}$  of the N.E. $\frac{1}{4}$  of section 22; thence south on ~~the~~  $\frac{1}{8}$  line 5280 feet to the S.E. corner of the S.W. $\frac{1}{4}$  of the S.E. $\frac{1}{4}$  of section 22. thence west on section line 1284 feet to the  $\frac{1}{4}$  post between sections 22 & 27; thence south on the  $\frac{1}{4}$  line 5280 feet to the quarter post between sections 27 & 34, thence west on the section line 6585 $\frac{1}{2}$  feet to the N.E. corner of the N.W. $\frac{1}{4}$  of the N.W. $\frac{1}{4}$  of section 33; thence south on the  $\frac{1}{8}$  line 2640 feet to the S.E. corner of the S.W.  $\frac{1}{4}$  of the N.W. $\frac{1}{4}$  of section 33; thence west on the quarter line to the place of beginning, containing 2560 acres and all in the Town of Prairie Farm in Barron County, Wisconsin and all in Township 32 Range 13.
