AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF
ATHENS, MARATHON COUNTY, WISCONSIN

The Village Board of the Village of Athens do ordain as follows:

SECTION 1. TERRITORY ANNEXED. In accordance with s. 66.021 of the Wisconsin Statutes of 1965, and the petition for direct annexation filed with the Village Clerk on the 22nd day of March, 1967, signed by a majority of the electors residing in the territory and the owners of one-half of the land in the area in the territory, the following described territory in the Town of Johnson, Marathon County, Wisconsin, is annexed to the Village of Athens, Wisconsin:

A parcel of land located in the NW fractional $\frac{1}{4}$ of the NE fractional $\frac{1}{4}$, Section 1, Township 29 North, Range 4 East, Town of Johnson, Marathon County, Wisconsin, more particularly described as follows:

Beginning at the Northwest corner of said NW fractional $\frac{1}{4}$ of NE fractional $\frac{1}{4}$ and thence South $0^{\circ} 05'$ East, 1,819.35 feet along West line of said fraction to South line of said fraction; thence South $87^{\circ} 56'$ East, 249.25 feet along South line of said fraction; thence North $0^{\circ} 05'$ West, 367.00 feet; thence South $87^{\circ} 56'$ East, 1,060.05 feet to East line of said fraction; thence North $0^{\circ} 00'$, 1,452.50 feet, to Northeast corner of said fraction; thence North $87^{\circ} 57'$ West, 1,311.30 feet along North line of said fraction to Place of beginning.

SECTION 2. MAP ATTACHED. The territory hereby annexed, and its environs, is shown on the map hereto attached and made a part hereof.

SECTION 3. EFFECT OF ANNEXATION. From and after the date of this ordinance, the territory described in Section 1 shall be a part of the Village of Athens for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Athens.

SECTION 4. EFFECTIVE DATE. This ordinance shall take effect upon passage and publication as provided by law.

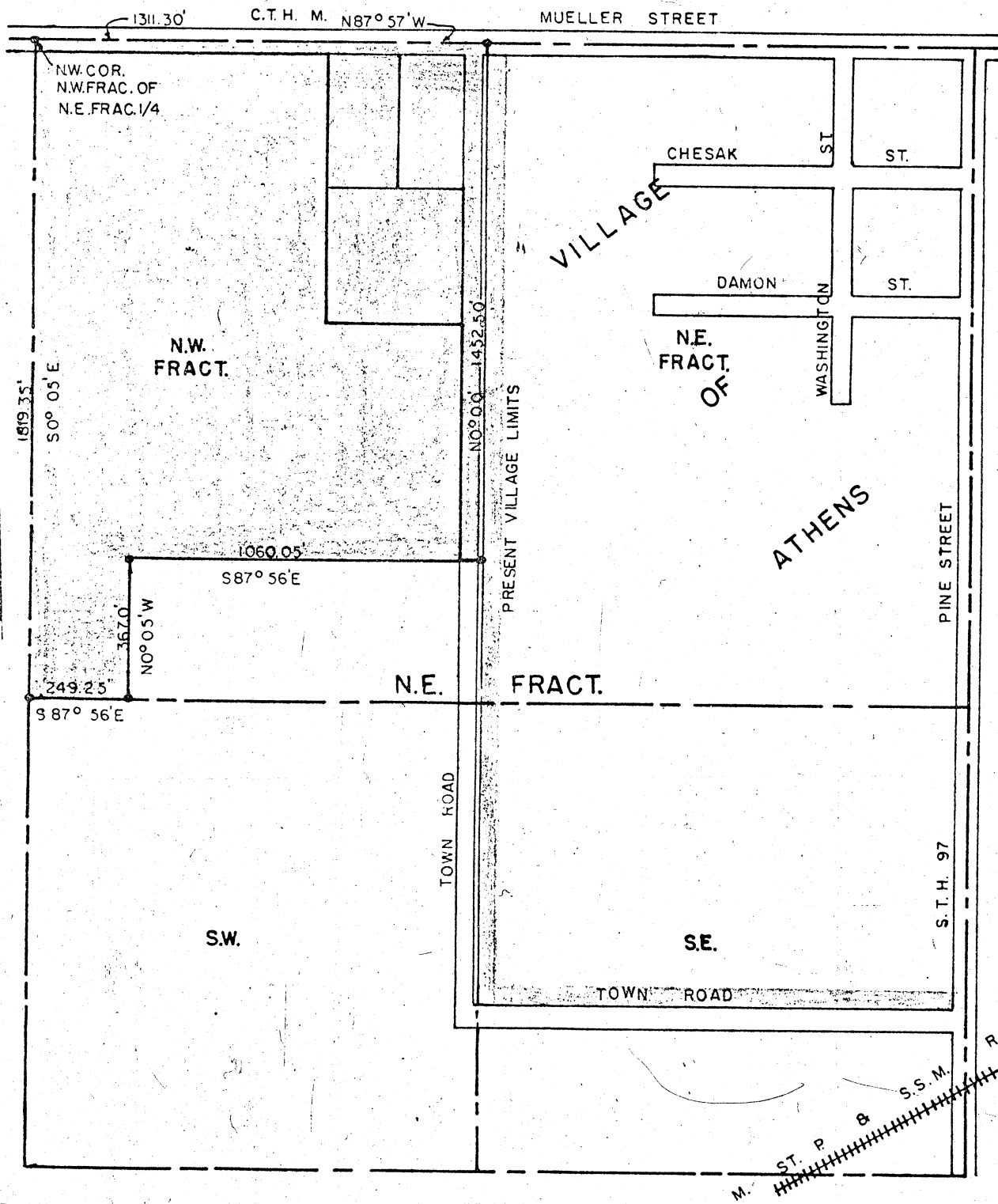
