Thence West 132.00';
Thence North, 148.50';
Thence West, 292.88' to the point of beginning;

All of the above described parcel of land being located in the NW $\frac{1}{4}$, NW $\frac{1}{4}$, Section 18, T. 12N., R. 3 E., Town of Ironton, Sauk County, Wisconsin;

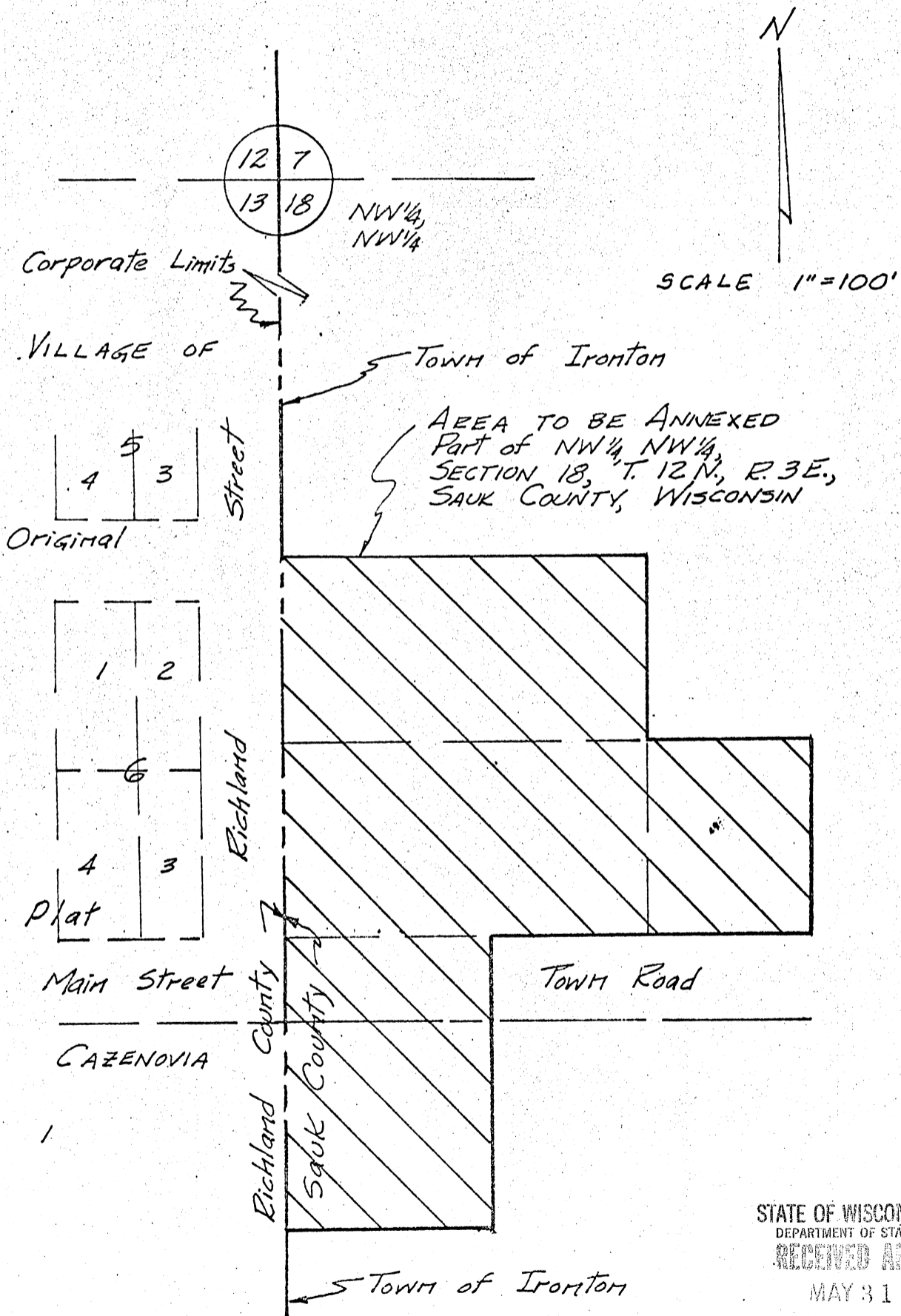
