At a regular term of the Circuit Court in and for Dodge County, in the State of Wisconsin, begun and held at the Court House in the City of Juneau, in said Dodge County, on the Fourth Tuesday of September A. D. 1907 and on this 4th day of January A. D. 1908.

Present Hon. M. L. Lueck, Circuit Judge.

This matter having come before me on the 21st day of December A. D. 1907 and having been duly adjourned to the 4th day of January A. D. 1908 and Lamoreux & Husting, attorneys at law, appearing for William Henschel, G. W. Killenbenz, Aug. Kettner, Ernst G. Zilisch, and Edgar Boeing who are the applicants for the incorporation of said Village of Hustisford, and Chris A. Christiansen, attorney at law, appearing for Ernst Bremer, Theodore Roessler, August Vogler Sr., Herman Kinlehaft and Otto Triten who objected to the petition filed herein, and after hearing the testimony presented and after hearing the arguments of the Counsel and being satisfied with the correctness of the map and survey herein, which map and survey was made by Geo. W. Morse, who is the County Surveyor and a resident of Juneau, Wisconsin, and which map and survey is dated August 24th A. D. 1907, and which was filed herein, and being satisfied with the correctness of the census taken which was filed herein, and which census was taken by Otto W. A. Radloff and was taken of the resident population of the territory to be incorporated as the Village of Hustisford, and all the requirements of the Statutes having been complied with and being satisfied and it appearing that such territory as is proposed to be included in such Village of Hustisford contained at the time the census was taken the population in number and in pro-

portion ot the quantity of land required by Section 854 of the

Wisconsin Statutes for the year 1898 as amended by Chapter 17 of the Laws of Wisconsin for the year 1907; said territory containing 320 acres of land and a resident population of 584.

IT IS ORDERED AND ADJUDGED.

That the territory herein described shall be an incorporated Village by the name specified in the application herein, to-wit: The Village of Hustisford; such territory is described as follows:

Said territory lying in the Town of Hustisford, in the County of Dodge and in the State of Wisconsin and is particularly described as follows: Commencing at the South East corner of Section number Nine (9) in Township number Ten (10) north of Range number Sixteen (16) east, thence north on section line eleven and thirty-four one hundredths (11.34) chains to south line of Ernst Braemers land. thence east Two (2) chains, thence north five and twenty-five one hundredths (5.25) chains, thence west Two (2) chains to section line, thence north twenty-three and twenty-three hundredths (23.23) chains to East quarter post of said Section Nine (9), thence west on 1 line fourteen and fifty one hundredths (14.50) chains, to the west bank of Rock River, thence north on said west bank sixteen and fifty one hundredths (16.50) chains, thence west twenty-nine and fifty one hundredths (29.50) chains to north and south $\frac{1}{4}$ line, thence south on 1 line twenty-nine chains (29), thence west forty one hundredths (40/100) chains, thence south four and seventy-one one hundredths (4.71) chains, to center of Juneau Road; thence west in center of sai d road thirty and thirty-five one hundredths (30.35) chains to west line of Park, thence south on line twentyone and seventy one hundredths (21.70) chains to south line of Section nine (9), thence east thirty and sixty-two one hundredths (30.62) chains to south $\frac{1}{4}$ post of section Nine (9), thence south on $\frac{1}{4}$ line nineteen and sixty-two one hundredths (19.62) chains, thence east on line forty and ninety-six one hundredths (40.96) chains to east line of Section Sixteen (16) in said Town, thence north on section line 19.56 chains to place of beginning.

Provided however that the electors thereof shall assent thereto as is proveded by Section 864 of the Wisconsin Statutes for the year 1898 and as provided by law and it is further ordered that the following named persons residing in the territory above described and who reside in the Town in which such territory lies, shall be and hereby are appointed inspectors of election and are authorized to perform the duties of inspectors as required by the Sections 862-866 of the Wisconsin Statutes for the year 1893 and acts amendatory thereof; said persons shall be as follows: William Henschel, Ernst Zilisch, and V. W. Anthony, all residing in the territory above described and in the Town of Hustisford, Dodge County, Wisconsin.

Such inspectors are authorized without unnecessary delay to give notice of a meeting of the electors of the territory described herein to be held in such territory and at some sonvenient place therein, within sixty days of the date of this order for the purpose of determining whether or not such territory above described shall be an incorporated village and such notice shall be given pursuant to Sections 862 and 863 of the Wisconsin Statutes for the year 1898 and said election held pursuant to Sections 862-863-864 of the Wisconsin Statutes for the year 1898 and acts amendatory thereoff and as provided in Chapter 40 of the Wisconsin Statutes for the year 1898 relating to the Incorporation of Villages.

Pursuant to the order of the Circuit Court of Dodge County, Wisconsin, in the above entitled matter and said order being signed on the 4th day of January A.D. 1908 the inspectors appointed by the Court to-wit, Wm. Henschel, Ernst Zilisch, and V.W. Anthony gave notice of an election pursuant to Section 862 of the Wisconsin Statutes of the year 1898, a copy of which is hereto annexed; that said notice of election was duly posted according to law, three copies of said notice being posted in three of the most conspicuous places in the Town of Hustisford, Dodge County, Wisconsin and in the territory mentioned in the notice at least three weeks previous to the election held on March 3rd, 1908; said notices being posted as follows:

- " " Hustisford Bank.

That pursuant to said notice and pursuant to the order of the Circuit Court herein an election was duly had and held at the place mentioned in said notice and at the time mentioned in the said notice; that there was and is no newspaper printed or published within the territory described in said notice; that the inspectors mentioned herein acted as inspectors of said election; that there were cast at such election in all 163 ballots; that 89 ballots had thereon the word "yes" and that 74 ballots had thereon the word "No"; a majority of the ballots cast at said election had thereupon the word "Yes". The majority of ballots in other words being in favor of the incorporation of the territory (as described in the order of the Court and in the notice hereto attached) as the Village of Hustisford under Chapter 40 of
