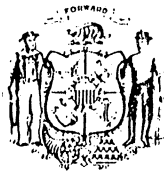

CHAPTER 36

AN ORDINANCE ANNEXING THE ST. CATHERINE'S
BAY AREA TO THE VILLAGE OF STOCKBRIDGE,
CALUMET COUNTY, WISCONSIN

BE IT ORDAINED by the Village Board of the Village of Stockbridge, Calumet County, Wisconsin, as follows:

36.01 AUTHORIZATION. A petition for Annexation and Request for Annexation referendum having been served on the Village Clerk for the Village of Stockbridge; a resolution having been passed, requiring the holding of such referendum, by the Village Board of the Village of Stockbridge; a referendum having been held on the annexation issue on April 1, 1986, and having passed, according to Wisconsin Statutes 66.021 the statutory requirements for annexing the property have been met.

36.02 TERRITORY ANNEXED. The territory described below is hereby annexed to the Village of Stockbridge, that being:

A parcel of land constituting Lot 15, 16, 17, 18, 19 and 20 of Township No. 19 North of Range No. 18 East, Town of Stockbridge, Calumet County, Wisconsin.

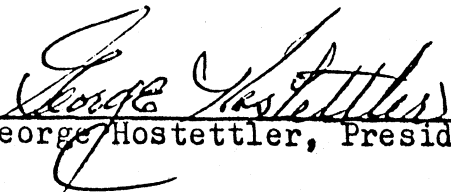
A plat of the territory hereby annexed is attached hereto as Exhibit "A".

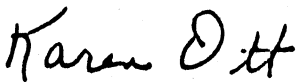
36.04 ZONING DISTRICT MAP. Pursuant to Section 66.021(7) Wisconsin Statutes the official zoning district map as provided

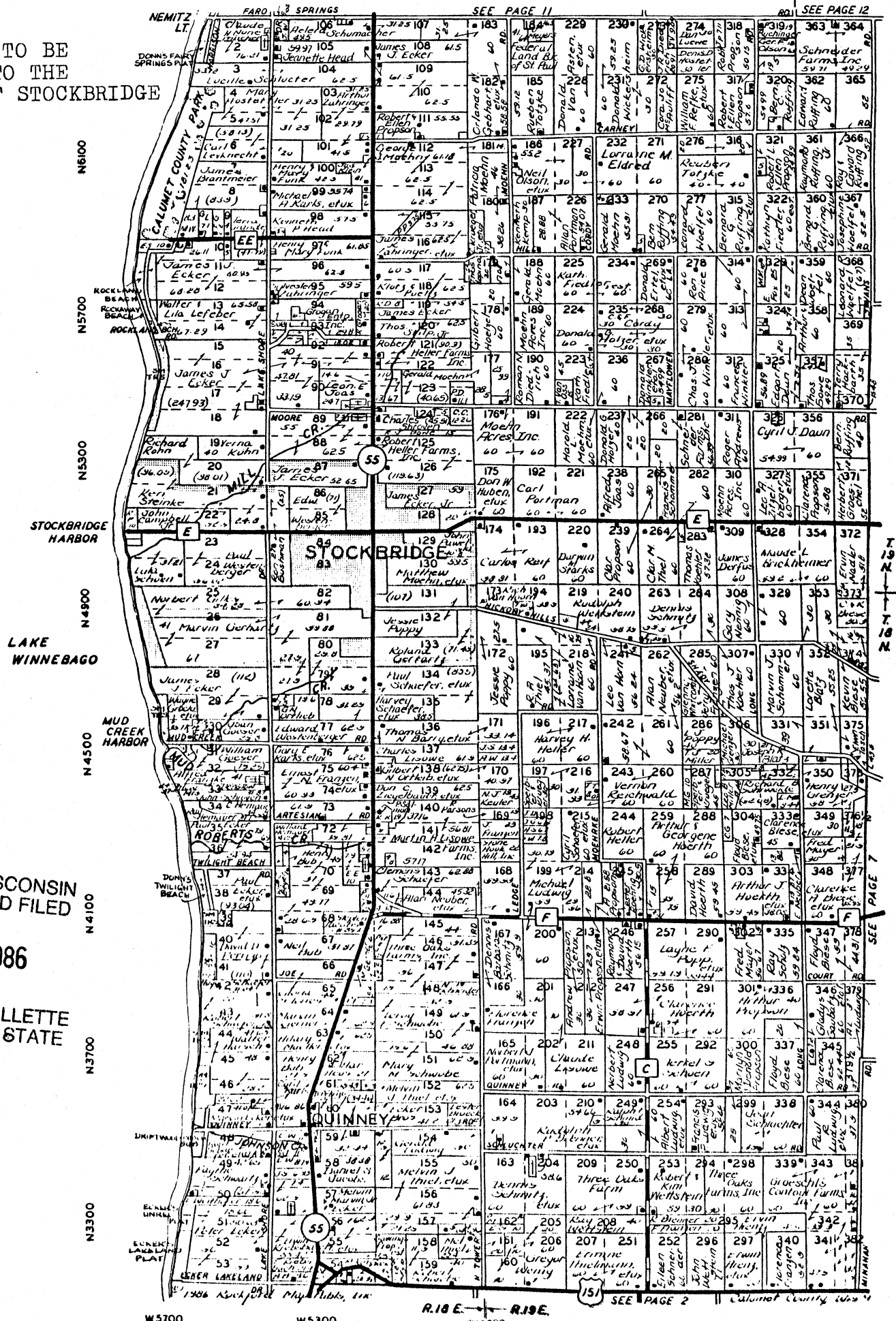
