IN THE MATTER OF THE APPLICATION TO DETACH AND DISCONNECT CERTAIN TERRETORY FROM THE VILLAGE OF PLUM CITY, PIERCE COUNTY, WISCONSIN.

At a special term of the Circuit Court for Pierce County, Wisconsin begun and held at the Court House in the Village of Ellsworth in said County on the first Tuesday being the 7th day of September 1915 and on the first day of said term, to-wit! on the 7th day of September A.D.1915 present Hon.George Thompson, Judge presiding.

The application by petition of Math Gilles, Sr., Albert Ingli, John Schwab, Ben Fox, Herman Barnsdorf and Nicholas Larsen for an order disconnecting and detaching certain territory from the territory now embraced within the present corporate limits of the Village of Plum City, Pierce County Wisconsin which said territory proposed to be detached is bounded by a line described as follows, to Wit: commencing at the Northwest corner of the Northeast Quarter of the Northwest Quarter of Section Fifteen (15) in Town Twentyfive (25) North of Range Fifteen (15) West, Pierce County, Wisconsin and ruhning thence East on the Section Line to the Quarter post in the North line of said section Fifteen (15); thence south on the quarter line to the southeast corner of said Northwest Quarter of said Section Fifteen (15); thence west on the south line of said Northwest Quarter of said Section to the southwest corner of Southeast Quarter of Northwest Quarter of said Section Fifteen; thence north on the west line of the East-half of said Northwest Quarter of said Section, to the place of beginning, containing Eighty Acres of land, coming on to be heard at this term and the said petitioners having appeared by their attorney John E.Foley; and it appearing to the Court from the proofs taken in open Court that the said applicants did on the 19th day of July 1915 cause to be made by a practical surveyor an accurate survey, map of the above described territory intended to be detached and disconnected

from said Village showing the courses and distances of the boundaries and the quantity of land that will be contained in such Village if such territory be detached therefrom and such proposed alterations in the boundaries of said Village be made; the accuracy of which survey and map was duly verified by such surveyor's affidavit annexed thereto; and that they did also on the 20th day of July A.D. 1915 cause to be taken an accurate census of the resident population of the territory to be contained in said Village of Plum City after detaching from the present territory embraced within the corporate limits of said Village the territory herein before described, which said census contains the name of every head of the family and the name of every person a resident in good faith of such territory on the 20th day of July A. D. 1915, and the lot or quarter section of land on which each such person resides, which census was duly verified by the affidavit of the person who took the same; that said map and census when so completed and verified was left with the Clerk of said Village of Plum City -- H.A. Plate at his office as Village Clerk in sid Village subject to the examination of every person interested, for the period from the 24th day of July 1915 -- a period of five (5) weeks; that the said petitioners gave due notice that they would apply to this court on the 7th day of September A. D. 1915 at Ten O'Clock in the forenoon of that day at the Court House in the Village of Ellsworth, Pierce County, Wisconsin for an order detaching from the territory now embraced within the corporate limits of said Village of Plum City, the territory herein before described, by causing due and sufficient notice of such application to be posted in Four (4) of the most public places within the corporate limits of said Village of Plum City on the 24th day of July A. D. 1915; that on the sixth day of September A.D.1915 the Board of Trustees of said Village of Plum City in regular meeting assembled did duly pass and adopt a resolution consenting that the territory herein before described be detached from

the present corporate limits of said Village of Plum City and did in all things consent to such proposed alteration in the boundaries of said Village; that all of the owners of the property comprised in the territory hereinbefore described as proposed to be detached and disconnected from said Village have consented to such alteration in the boundaries of said Village and to the detachment and disconnection of the territory hereinbefore described from the present territory embraced within the corporate limits of said Village.

AND IT FURTHER APPEARING that after detaching from the territory embraced within the present corporate limits of said Village of Plum City, the territory hereinbefore described as proposed to be detached, there will still remain within the corporate limits of said village an area of SIX HUNDRED FORTY acres (640) which is greater that that required by section 854 of the Wisconsin Statutes for the year 1913 and the acts amendatory thereof and that the resident population of the territory embraced within the corporate limits of said village of Plum City after detaching therefrom the territory hereinbefore described as proposed to be detached is Three Hundred Fifty (350) bona fide residents in good faith;

AND ON MOTION of John E. Foley, attorney for said petitioners,

described as follows, to-wit; commencing at the Northwest corner of the Northeast Quarter of the Northwest Quarter of Section Fifteen (15) in Town Twenty-Five (25) North of Range Fifteen (15) West, Pierce County, Wisconsin and running thence East on the Section Line to the Quarter Post in the North line of said Section Fifteen (15); thence south on the Quarter line to the Southeast corner of said Northwest Quarter of said Section Fifteen (15); thence west on the south line of said Northwest Quarter of Southeast Quarter of Southeast Quarter of Southeast Quarter of Southeast Quarter of Northwest Quarter of said section Fifteen (15) thence North on the west line of the East-Half of said Northwest Quarter of said section, to the place of beginning,
