



DESCRIPTION OF
LOHRVILLE WISCONSIN
CORPORATE BOUNDARY

Lands located in Waushara County Wisconsin, the north one half of Section 18, the north one half of the south one half of Section 18, T 18 N, R 12 E, and also the northeast one quarter of the northeast one quarter and part of the southeast one quarter of the northeast one quarter of Section 13, T 18 N, R 11 E, and also part of the southwest one quarter of Section 7, T 18 N, R 12 E. The exterior boundary is described as follows:

Beginning at the northeast corner of said section 18; thence south along the east line of said section 18, 3981.5 feet to the southeast corner of the northeast one quarter of the southeast one quarter of said section 18; thence west along the south line of the north one half of the south one half of said section 18, 5691.1 feet to the southwest corner of said north one half of south one half of said section 18; thence north 2396.8 feet along the west line of said section 18 to a point 230.7 feet south of the northwest corner of the southwest one quarter of the northwest one quarter of said section 18; thence S 75°00' W, 1368 feet to the west line of said southeast one quarter of said northeast one quarter of said section 13; thence north 1900 feet along said west line and along the west line of the northeast one quarter of the northeast one quarter of said section 13; thence east 1323 feet along the north line of said northeast one quarter of said northeast one quarter to the northeast corner of said section 13; thence North 2416.40 feet along the west line of said section 7 to the north line of S.T.H. 21; thence S 83°05' E, 363.39 feet along said highway; thence N 8°20' E, 264.17 feet; thence N 88°17' E, 617.84 feet; thence easterly 420 feet along the north line of said southwest one quarter of said section 7 to the northeast corner of the west one half of said southwest one quarter; thence south 452 feet along the east line of said west one half of said southwest one quarter of section 7 to the center of S.T.H. 21; thence S 83°05' E, 193.38 feet along said center; thence S 77°49' E, 498.96 feet to a point in the center of S.T.H. 21; thence S 71°53' E, 557.89 feet along the center of said S.T.H. 21; thence South 1857.73 feet to the north line of said section 18; thence east 3119.13 feet along said north line of section 18 to the point of beginning.
