CERTIFICATE OF ANNEXATION

VILLAGE OF JACKSON : WASHINGTON COUNTY : STATE OF WISCONSIN

We, Clem Mayer, President of the Village of Jackson, Washington County, Wisconsin, and F. H. Ackerman, Clerk of the Village of Jackson, Washington County, Wisconsin, do hereby certify that the following territory situated in Washington County, Wisconsin, to-wit:

That part of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 17, Township 10 North, Range 20 East, described as follows, to wit:

Commencing at the Southwest Corner of the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 17-10-20; thence East 20.00 feet to the place of beginning; thence North 250 feet; thence East 87.00 feet; thence South 250.00 feet; thence West 87.00 feet to the place of beginning.

Has been annexed to the Village of Jackson pursuant to ordinance enacted by the Village Board of said Village on May 13th, 1958, and signed and countersigned by said Village President and Clerk, on the same date, and published pursuant to law; and,

We further certify that the following territory situated in Washington County, Wisconsin, to wit:

That part of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 19, Township 10 North, Range 20 East, described as follows:

Commencing at the North $\frac{1}{4}$ corner of Section 19, Township 10 North, Range 20 East; thence West along the North line of the NW $\frac{1}{4}$ of said Section 19, 330.00 feet to the point of beginning; thence Southerly in Section 19 and parallel to the North $\frac{1}{4}$ line of Section 19, 165.00 feet; thence East, 335.00 feet to the North $\frac{1}{4}$ line; thence Southerly on the North $\frac{1}{4}$ line, 495 feet; thence Easterly

673.00 feet to the Westerly line of Western Ave; Thence South-
erly 20.00 feet to the South line of South Street; thence
Easterly on the South line of South Street 40.00 feet to the
Westerly line of Lot 36 of the First Addition to the Village of
Jackson; thence Southerly on the West line of the aforesaid Lot 36,
150.00 feet to the South line of aforesaid Lot 36; thence Easterly
and parallel to the South line of South Street, 275.00 feet; thence
Southerly and parallel to the West line of Lot 36, 160.00 feet;
thence Easterly 807.36 feet to a point in the Easterly R. O. W.
line of the C. & N.W. R.R. Co.; thence South 06 degrees 59
minutes East on the aforesaid R. O. W. line 200.10 feet; thence
North 89 degrees 50 minutes West on R.O.W. line 114.33 feet;
thence South 06 degrees 59 minutes East on the R.O.W. line
397.62 feet; thence West and parallel to the North line of NW $\frac{1}{4}$
of aforesaid Section 19, 2439.14 feet; thence North and right
angles to the North line of aforesaid NW $\frac{1}{4}$ of Section 19, 1587.96
feet to the aforesaid North line of the NE $\frac{1}{4}$ of Section 19; thence
East on the North line of the NE $\frac{1}{4}$ of Section 19, 354.00 feet to
the point of beginning.
