

thence westerly along the southerly right-of-way line of State Trunk Highway 82 to a point being in the southerly extension of the westerly right-of-way line of County Trunk Highway J; thence northerly along the westerly right-of-way line of County Trunk Highway J and the southerly extension thereof to a point in the north line of the Southeast Quarter of the Northwest Quarter, thence westerly along the north line of the Southeast quarter of the Northwest Quarter to the northwest corner of said Southeast Quarter of the Northwest Quarter; thence southerly along the west line of the Southeast Quarter of the Northwest Quarter to the northeast corner of the south half of the Southwest Quarter of the Northwest Quarter of Section 16; thence westerly along the north line of the south half of the Southwest Quarter of the Northwest Quarter to the northeast corner of the south half of the Southeast Quarter of the Northeast Quarter of Section 17; thence westerly along the north line of the south half of the Southeast Quarter of the Northeast Quarter of Section 17 to a point in the west line of the east half of the Northeast Quarter of Section 17, thence northerly along the west line of the east half of the Northeast Quarter to a point in the southerly line of Lot 1, Certified Survey Map, No. 301; thence westerly and northwesterly along the south line of Lot 1, Certified Survey Map, No. 301 to a point in the easterly right-of-way line of County Trunk Highway A; thence southwesterly along the easterly right-of-way line of County Trunk Highway A to a point in the north line of the Southwest Quarter of the Northeast Quarter; thence westerly along the north line of the Southwest Quarter of the Northeast Quarter to the northwest corner of the Southwest Quarter of the Northeast Quarter; thence westerly along the north line of the Southeast Quarter of the Northwest Quarter to a point in the easterly right-of-way of Neenah Drive;
