ORDINANCE

AN ORDINANCE, DETACHING CERTAIN TERRITORY, KNOWN AS THE EXTENSION CENTER SITE, FROM THE VILLAGE OF KOHLER.

Whereas, a petition by the County of Sheboygan for detachment of certain lands from the Village of Kohler, known as the Extension Center Site and hereinafter more particularly described, was filed with the Village of Kohler on the 7th day of August, 1964; and,

Whereas, said detachment petition was authorized by resolution No. 26 of the Sheboygan County Board of Supervisors to permit annexation of the territory to the City of Sheboygan; and,

Whereas, the interests of all concerned would be best served by the detachment of such territory from the Village of Kohler and its annexation to the City of Sheboygan;

Now, Therefore, the Board of Trustees of the Village of Kohler do Ordain as follows:

1. That there be, and there hereby is, detached from the Village of Kohler the following described territory presently situated in the Village of Kohler, County of Sheboygan, State of Wisconsin, to wit:

That part of Government Lot 5, Section 28, Town 15 North, Range 23 East, lying East of the Easterly right-of-way line of proposed U.S. Highway 141 and that part of government Lot 6, of said Section 28, lying within the corporate limits of the Village of Kohler, Wisconsin, all presently held in title by Sheboygan County, and more particularly described as follows:

Commencing at the intersection of the Easterly right-of-way line of proposed U.S. Highway 141 and the South line of Government Lot 5, Section 28, Town 15 North, Range 23 East, running thence North eighty-nine (89) degrees nine (09) minutes eight (08) seconds East one thousand three hundred eight and twentynine one-hundredths (1308.29) feet along the South line of Government Lots 5 and 6, of said Section 28 to its junction with the present Kohler Village limits, thence North two (2) degress fifteen (15) minutes twenty-two (22) seconds West one thousand sementy-three and nine-tenths (1073.9) feet altong the present Kohler Village limits, thence North eighty-eight (88) degrees twenty-two (22) minutes eight (08) seconds East two hundred eighty-four and ninety-two one-hundredths (284.92) feet along said Kohler Village limits, thence North zero (0) degrees #our (04) minutes fifty-two (52) seconds West seven hundred three and five-tenths (703.5) feet along said Kohler Village limits to the South bank of the Sheboygan River, thence Westerly two thousand seventy (2070) feet more or less along said South bank to its intersection with the East right-of-way line of proposed U.S. Highway 141, thence South fifteen (15) degrees nine(09) minutes fifty-two (52) seconds East four hundred forty-one and twenty-eight one-hundredths (441.28) feet to a point of curve, thence Southerly

one thousand six hundred fifty-four and fortyseven one-hundredths (1654.47) feet along said curve, being convex Easterly having a radius of five thousand eight hundred ninety-nine and sixtyfive one-hundredths (5899.65) **geet**, whose chord bears South seven (7) degrees forty-one (41) minutes fifty-two (52) seconds East one thousand six hundred forty-nine and four one-hundredths (1649.04) feet to the point of beginning, said tract containing seventy-two and fifty-six one-hundredths (72.56) acres of land, being a part of Government Lots 5 and 6, Section 28, Town 15 North, Range 23 East.

2. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

3. This ordinance shall be in full force and effect upon its passage and publication.
