

Description of the Boundary of the Village of Kohler,
Wisconsin

Commencing at the Southwest corner of Section 31, Town 15 North, Range 23 East, running thence North 89 degrees 34 minutes East 2,650.13 feet to the South one-quarter ($1/4$) corner of said Section 31, thence North 89 degrees 27 minutes East 2,649.8 feet along the South line of said Section 31 to the Southeast corner of said Section which point is also the Southwest corner of Section 32, thence North 89 degrees 24 minutes East 3,986.8 feet along the South line of said Section 32 to the Southeast corner of Government Lot 9, of said Section 32, thence North 0 degrees 13 minutes East 2,515.0 feet along the East line of said Government Lot 9 to the right bank of the Sheboygan River, thence continuing North 0 degrees 13 minutes East 120 feet, more or less, to the left bank of the Sheboygan River, thence downstream along said left bank to the point where said bank is intersected by the North $1/8$ th line of Section 32, thence North 89 degrees 17 minutes East along said $1/8$ th line 1,352.1 feet to the Southeast corner of the Northeast $1/4$ of the Northeast $1/4$ of said Section 32, thence North 1 degree 01. minute West along the East line of Section 32, 1,305.7 feet to the Northeast corner of said Section 32, thence North 88 degrees 25 minutes East 2,666.2 feet along the South line of Section 28, Town 15 North, Range 23 East to the South $1/4$ corner of said Section, thence North 0 degrees 55 minutes West 1,324.0 feet, thence South 88 degrees 05 minutes West 660.5 feet, thence South 89 degrees 09 minutes 08 seconds West 1,308.29 feet along the South line of Government Lots 6 and 5 of Section 28, to its intersection with the Easterly right-of-way line of proposed U. S. Highway 141, thence Northerly along said Easterly right-of-way line and the arc of a curve 1,654.47 feet, said curve being convex Easterly having a radius of 5,899.65 feet, whose chord bears North 7 degrees 41 minutes 52 seconds West 1,649.04 feet to a point, thence North 15 degrees 09 minutes 52 seconds West along said proposed Easterly right-of-way line of U. S. Highway 141, 441.28 feet to a point on the right bank of the Sheboygan River, thence upstream along said right bank to its intersection with the right-of-way reference line of U. S. Highway 141 (Project T01-3(18), thence North 15 degrees 09 minutes 52 seconds West 615.0 feet, more or less, along said reference line to its intersection with the East line of Section 29, Town 15 North, Range 23 East, thence North 0 degrees 19 minutes West 143.6 feet along said Section line to its intersection with

the centerline of the Middle Road, thence South 62 degrees 04 minutes West 35.0 feet along the centerline of the Middle Road to its intersection with the right-of-way reference line of U. S. Highway 141 (Project T01-3(18), thence North 15 degrees 09 minutes 52 seconds West along said reference line to a point which is 104.0 feet Southerly of the intersection of said reference line with the North line of Section 29, Town 15 North, Range 23 East, thence North 0 degrees 21 minutes East to a point on the North line of said Section 29, thence North 88 degrees 24 minutes East 92.5 feet along said Section line, thence North 0 degrees 48 minutes West 1113.6 feet to a point in the centerline of the Upper Road, thence South 62 degrees 14 minutes West along said centerline to its intersection with the right-of-way reference line of U. S. Highway 141 (Project T01-3(18) North 15 degrees 09 minutes 52 seconds West 1,807.9 feet to a point in the East and West 1/4 line of Section 20, thence West 1,542. feet, more or less, along said East and West 1/4 line to the center of Section 20, Town 15 North, Range 23 East, thence South 89 degrees 26 minutes West 1,329.2 feet along said 1/4 line to the East line of the West 1/2 of the Northwest 1/4 of Section 20, thence North 0 degrees 59 minutes West 2,367.5 feet along the East line of said West 1/2 of the Northwest 1/4 to a point 293.6 feet Southerly of the North line of Section 20, thence South 89 degrees 36 minutes West 1,015.88 feet along a line parallel to the North line of Section 20, thence South 89 degrees 39 minutes West 33.0 feet, thence South 0 degrees 27 minutes East 660.2 feet, thence South 89 degrees 35 minutes West 263.3 feet to the West line of said Section 20, thence North along said West line of Section 20 to a point 340.0 feet South of the Northwest corner of said Section 20, thence West parallel with the North line of Section 19, Town 15 North, Range 23 East 520.1 feet, thence North parallel to the East line of said Section 19, 67.75 feet, thence West parallel to the North line of said Section 160.0 feet to the West line of the East 1/2 of the East 1/2 of the Northeast 1/4 of Section 19, thence South along said West line to a point 2,264.2 feet North of the East and West 1/4 line of said Section 19, thence West 675.8 feet parallel with the North line of said Section 19, thence South 0 degrees 49 minutes East 255.3 feet, thence South 89 degrees 35 minutes West 772.75 feet, thence North 0 degrees 17 minutes West 378.7 feet, thence South 89 degrees 35 minutes West 572.9 feet parallel with the North line of said Section 19, to a point in the North and South 1/4 line of said Section 19, said point being 264.0 feet South of the North 1/4 corner of said Section 19, thence South 0 degrees 12 minutes East 79.25 feet

along said North and South 1/4 line to a point 343.25 feet Southerly of the North 1/4 corner of said Section 19, thence Westerly parallel to the North line of said Section 19 and 343.25 feet Southerly therefrom to a point in the West line of the East 1/2 of the Northwest 1/4 of said Section 19, thence South along the West line of the East 1/2 of the Northwest 1/4 and the West line of the East 1/2 of the Southwest 1/4 of said Section 19 to the South line of said Section 19, thence Southerly 662.4 feet along the West line of the East 1/2 of the Northwest 1/4 of Section 30, Town 15 North, Range 23 East, thence Westerly 1,382.4 feet to a point in the West line of said Section 30, said point being 659.7 feet Southerly of the Northwest corner of said Section 30, thence Southerly 3,711.5 feet along the West line of said Section 30, to its intersection with the centerline of State Trunk Highway 23, thence South 0 degrees 32 minutes East 928.4 feet to the Southwest corner of Section 30, thence South 0 degrees 38 minutes East along the West line of Section 31, Town 15 North, Range 23 East, 5,300.6 feet to the point of beginning; except the following tract of land,

Commencing at the Southwest corner of Section 30, Town 15 North, Range 23 East, thence North 0 degrees 32 minutes West 928.4 feet to the centerline of State Trunk Highway 23, thence North 61 degrees 03 minutes East 1,527.1 feet along the centerline of said State Trunk Highway 23 to the true point of beginning, running thence North 61 degrees 03 minutes East 1,496.5 feet, thence North 0 degrees 05 minutes West 541.6 feet, thence South 61 degrees 58 minutes West 595.5 feet, thence South 89 degrees 54 minutes West 803.0 feet to a point in the West line of the East 1/2 of the West 1/2 of Section 30, thence South along said West line of the East 1/2 of the West 1/2 to the point of beginning, said tract of land being the Sheboygan Falls Cemetery.

The above description of the Village of Kohler, Wisconsin, contains 3,287.15 acres or 5.14 square miles of land and is a part of Sections 19, 20, 28, 29, 30 and 32, and all of Section 31 in Town 15 North, Range 23 East.
