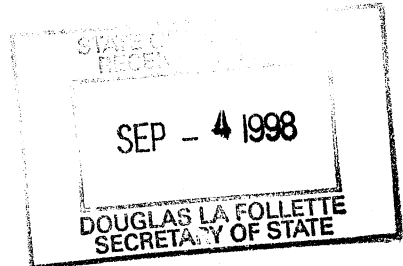

ORDINANCE NO. 82-3

AN ORDINANCE ANNEXING TERRITORY
WHICH WAS DETACHED FROM THE
TOWN OF SHEBOYGAN

The Village Board of the Village of Kohler does
ordain as follows:

A petition having been filed with the Village Clerk
on June 28, 1982, for direct annexation to the Village of
Kohler of territory hereinafter described, pursuant to
Section 66.021, Wis. Stats.; and

It appearing conclusively from said petition and
otherwise that said petition, after notice duly published
pursuant to statute in The Sheboygan Press, a newspaper of
general circulation in said territory, on June 9, 1982, was
signed by the owners of one-half of the land in area and/or
the owners of one-half of the real property in assessed
value within said territory; and

It appearing further that the proposed annexation is
lawful and proper under the aforesaid statute and generally
beneficial under the circumstances;

NOW, THEREFORE,

1. Annexation of Territory: The territory described in Appendix "A" attached hereto, incorporated herein and made a part hereof, which is presently situated in the Town of Sheboygan, is hereby annexed to the Village of Kohler.
2. Zoning: The zoning use district of such property shall be set forth on the Kohler Village Master Plan adopted December 16, 1980 by the Village of Kohler Planning Commission.
3. Effective Date: The herein ordinance shall take effect upon its adoption and posting in the Village in three (3) public places.
