CERTIFICATE FOR REPORTING CORPORATE LIMITS

OF VILLAGE AFTER ALTERATION

(Pursuant to Section 66.021(8) Wisconsin Statutes)

I, Arno Pfeifer, Village Clerk of the Village of Glenbeulah, County of Sheboygan, State of Wisconsin, DO HEREBY CERTIFY that the corporate boundaries of the said Village have been altered within the previous 12-month period ending December 1, 1967, and that the following description is the present corporate limits of the said Village as of December 1, 1972:

Beginning at the northeast corner of Section 1, T15N, R20E; Thence south along the east line of said Section 1 to the southeast corner of the NE 1/4 - SE 1/4 in said Section 1; Thence west along the south line of the NE 1/4 - SE 1/4 to a point 100 feet east of the southwest corner of Lot 21, Block 9, Division 2, Village of Glenbeulah; Thence south 75 feet; Thence west to the centerline of County Trunk Highway "S"; Thence northerly along said centerline to the north line of the SE 1/4 - SE 1/4 in said Section 1; Thence west along said north line to the northwest corner of the said SE 1/4 - SE 1/4; Thence south along the west line of the said SE 1/4 - SE 1/4, 412.5 feet; Thence west to a point on the north-south 1/4 line of said Section 1; Thence north along said 1/4 line 412.5 feet to the southeast corner of the NE 1/4 - SW 1/4 in said Section 1; Thence west to the center of the Mullet River; Thence southwesterly along the center of the Mullet River to its intersection with the centerline of Clark Street (C.T.H. "A"); Thence northeasterly along said centerline to the south line of the said NE 1/4 - SW 1/4; Thence west along the south line of the said NE 1/4 - SW 1/4 to the southwest corner thereof; Thence north along the west line of the said NE 1/4 - SW 1/4 and the E 1/2 - NW 1/4 to the north line of said Section 1; Thence east along said north line to the northeast corner of said Section 1 and the point of beginning.
