ANNEXATION ORDINANCE

The Petition for direct annexation submitted by Johanna Flohr as owner and a majority of the residents of the following described lands and premises located in the County of Rusk and State of Wisconsin, to-wit:

be and the same are hereby annexed to the Village of Glen Flora, from the Town of True.

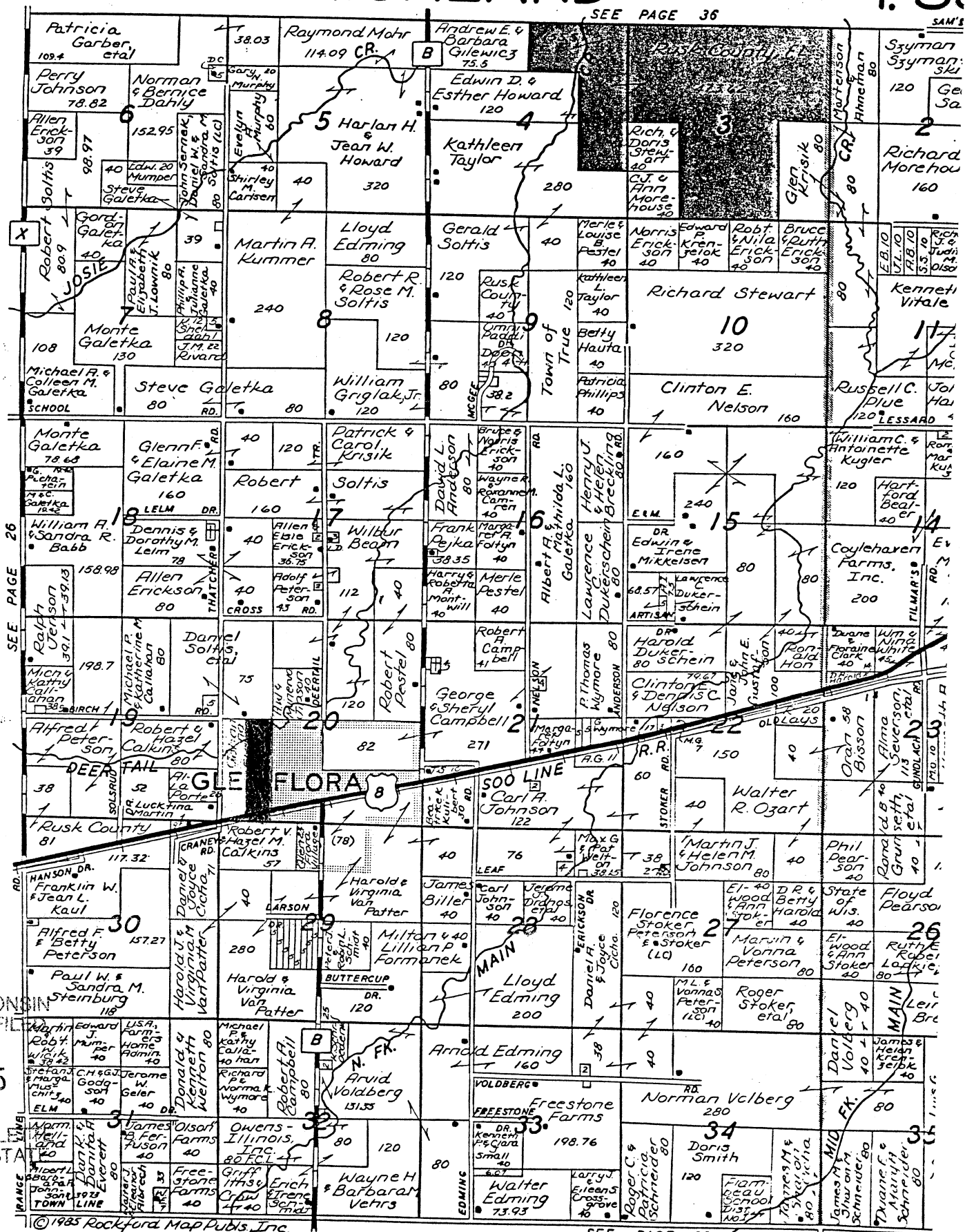
