

3. That since adoption of such Ordinance, it has not been repealed, amended or otherwise altered.

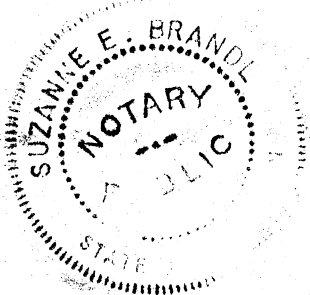

ORDINANCE NO. 23

AN ORDINANCE OF THE VILLAGE OF MINONG, WASHBURN COUNTY, WI, TO ANNEX A PART OF THE SE $\frac{1}{4}$ OF SECTION 26, TOWNSHIP 42 NORTH OF RANGE 12 WEST, WASHBURN COUNTY, WISCONSIN.

WHEREAS, Section 66.021(12) provides for the annexation of territory to a Village if an annexation petition for direct annexation is signed by all of the electors residing within a territory to be annexed and all of the owners of real property in such territory, and

WHEREAS, a petition has been filed requesting direct annexation of certain lands signed by the owners of all of the real property described in said petition, and

WHEREAS, there are no electors residing within such territory,

NOW THEREFORE, the Village Board of the Village of Minong, Washburn County, Wisconsin, in regular session duly assembled the 2nd day of October, 1975, do ordain as follows:

1. That the territory hereinafter described shall be and is hereby annexed to the Village of Minong, Washburn County, Wisconsin, to-wit:

That part of the Southeast Quarter (SE $\frac{1}{4}$), Section Twenty-six (26), Township Forty-two (42) North of Range Twelve (12) West further described as follows: Commencing at the East quarter corner of said section; thence South 1 deg. 50 min. 25 sec. West along the East line of said section; 2653.11 ft. to the Southeast corner of said section; thence South 88 deg. 01 min. 45 sec. West, along the South line of said section, 803.81 ft. to the center line of the Chicago and Northwestern right-of-way; thence North 38 deg. 49 min. 41 sec. West, along said center line, 1432.56 ft.; thence along the arc of a curve with a chord bearing North 36 deg. 53 min. 21 sec. West, 235.01 ft.; thence along the arc of a curve with a chord bearing North 26 deg. 54 min. 31 sec. West, 510.49 ft.; thence along the arc of a curve with a chord bearing North 11 deg. 15 min. 54 sec. West, 516.52 ft.; thence along the arc of a curve with a chord bearing North 4 deg. 03 min. 00 sec. East, 489.46 ft. to the intersection point of said center line of railroad and the North line of the SE $\frac{1}{4}$ section 26; thence South 87 deg. 13 min. 30 sec. East, along said North line, 875.64 ft.;

thence South 88 deg. 38 min. 00 sec. East along said North line, 1350.93 ft. to the point of beginning. Said parcel containing 109.32 acres, more or less: Said parcel to exclude Chicago & Northwestern right-of-way as shown on the map.

2. That the Village Clerk shall be and is hereby directed to mail a copy of the scale map and the description of the territory annexed hereunder to the office of the Secretary, Department of Local Affairs and Development, 123 West Washington Avenue, Madison, Wisconsin.

3. That this Ordinance shall take effect after its passage and publication as required by law.

Adopted unanimously this 2nd day of October, 1975.

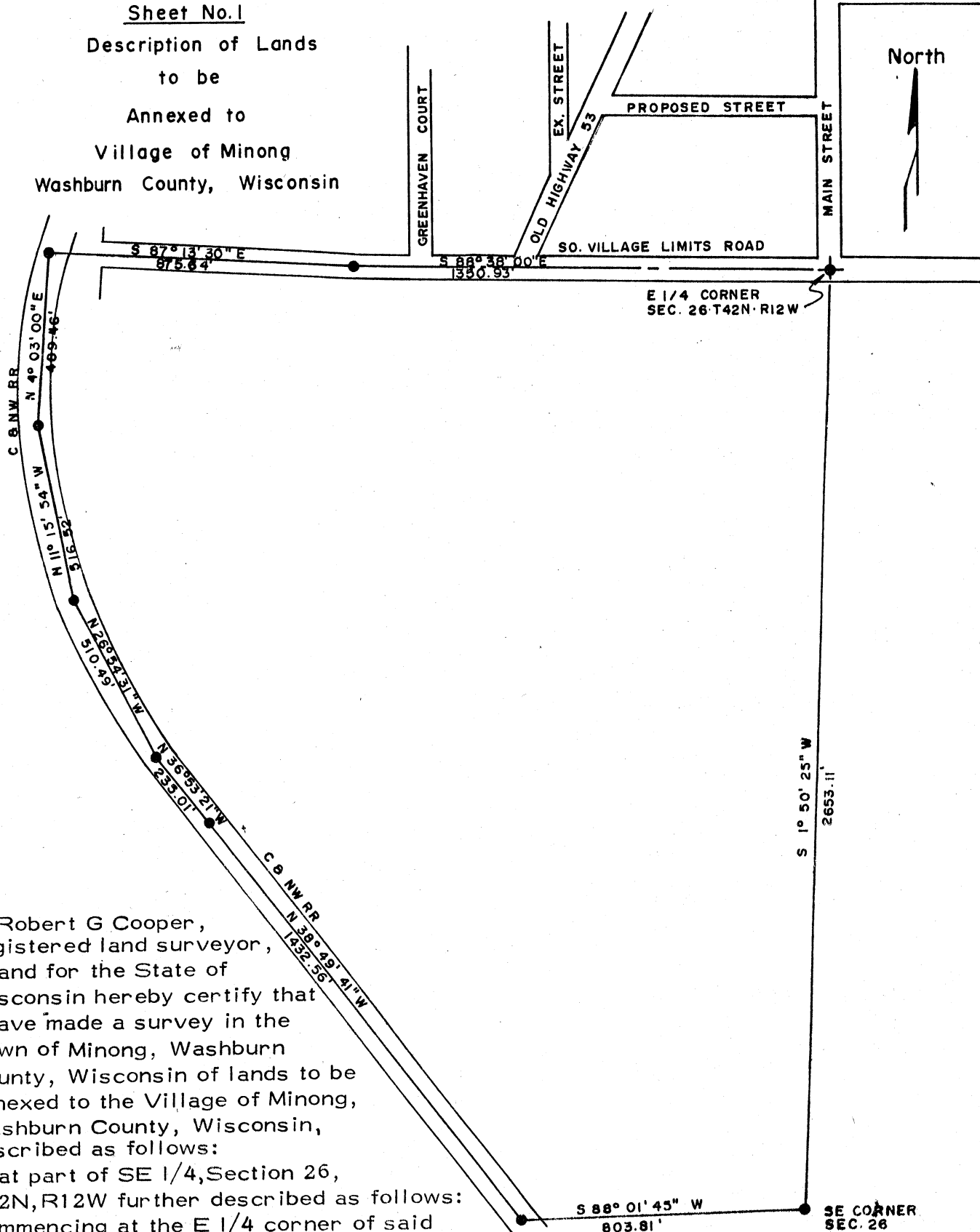

arc of a curve with a chord bearing N 11° 15' 54" W, 516.52'; thence along the arc of a
curve with a chord bearing N 4° 03' 00" E, 489.46' to the intersection point of said
center line of railroad and the north line of the SE 1/4 section 26; thence S 87°
13' 30" E, along said north line, 875.64'; thence S 88° 38' 00" E along said north line,
1350.93' to the point of beginning. Said parcel containing 109.32 acres, more or
less: Said parcel to exclude Chicago & Northwestern right-of-way as shown on the
map.
