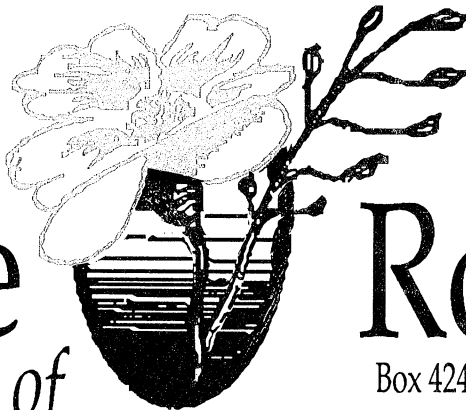

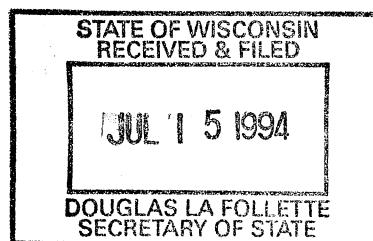

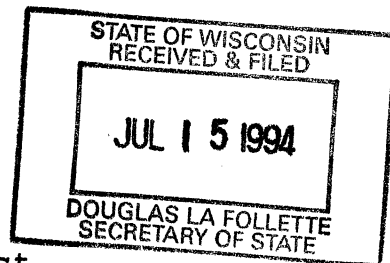
AN ORDINANCE ANNEXING  
TERRITORY TO THE VILLAGE OF ROSENDALE, WISCONSIN

The Village Board of the Village of Rosendale, Wisconsin does hereby ordain as follows:

Section 1. Territory Annexed. In accordance with 66.021, Wisconsin Statutes, and the Petition for Direct Annexation filed with the Village Clerk, signed by the owner(s) and elector(s) in the following described property presently in the Town of Rosendale, Fond du Lac County, Wisconsin, the following property is hereby annexed to the Village of Rosendale, Fond du Lac County, Wisconsin:

Property located in the Southwest One-Quarter (SW 1/4) of the Northwest One-Quarter (NW 1/4) of Section 36, Township 16 North, Range 15 East, Fond du Lac County, Wisconsin, and is more particularly described as follows:

Beginning at the Southwest corner of the Northwest quarter of Section 36, T16N-R15E, thence proceeding along the West line of the Northwest quarter (1/4), Section 36-16-15, North 1°-11' West, 380.10 feet, thence North 89°-35' East, 125.50 feet, thence South 1°-11' East 380.10 feet, thence South 89°-35' West, 120.50 feet to the point of beginning; the southerly 33 feet of said lot being subject to the rights of the public.



Section 2. Effect of Annexation. From and after the posting of this ordinance as required by law, the territory described in Section 1 shall be a part of the Village of Rosendale, Fond du Lac County, Wisconsin, for any and all purposes provided by law; all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Rosendale; all said territory is hereby annexed for school purposes and is thereby made a part of the School District of Rosendale, and subject to all of the laws governing same.

Section 3. Zoning. Said territory shall come into the Village of Rosendale zoned Residential.

Section 4. Filings. The Village Clerk shall file the ordinance as provided in Section 66.021 of the Wisconsin Statutes.

Section 5. Effective Date. This ordinance shall be effective upon adoption, publication and as provided by law.

Adopted this 11<sup>th</sup> day of July, 1994 by two-thirds of the elected officials of the Village of Rosendale, Wisconsin.

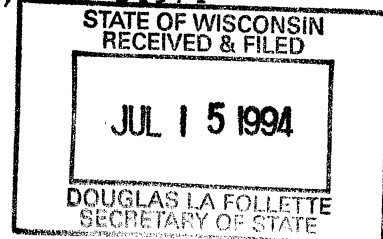

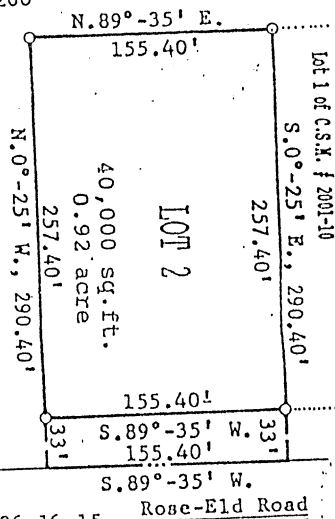

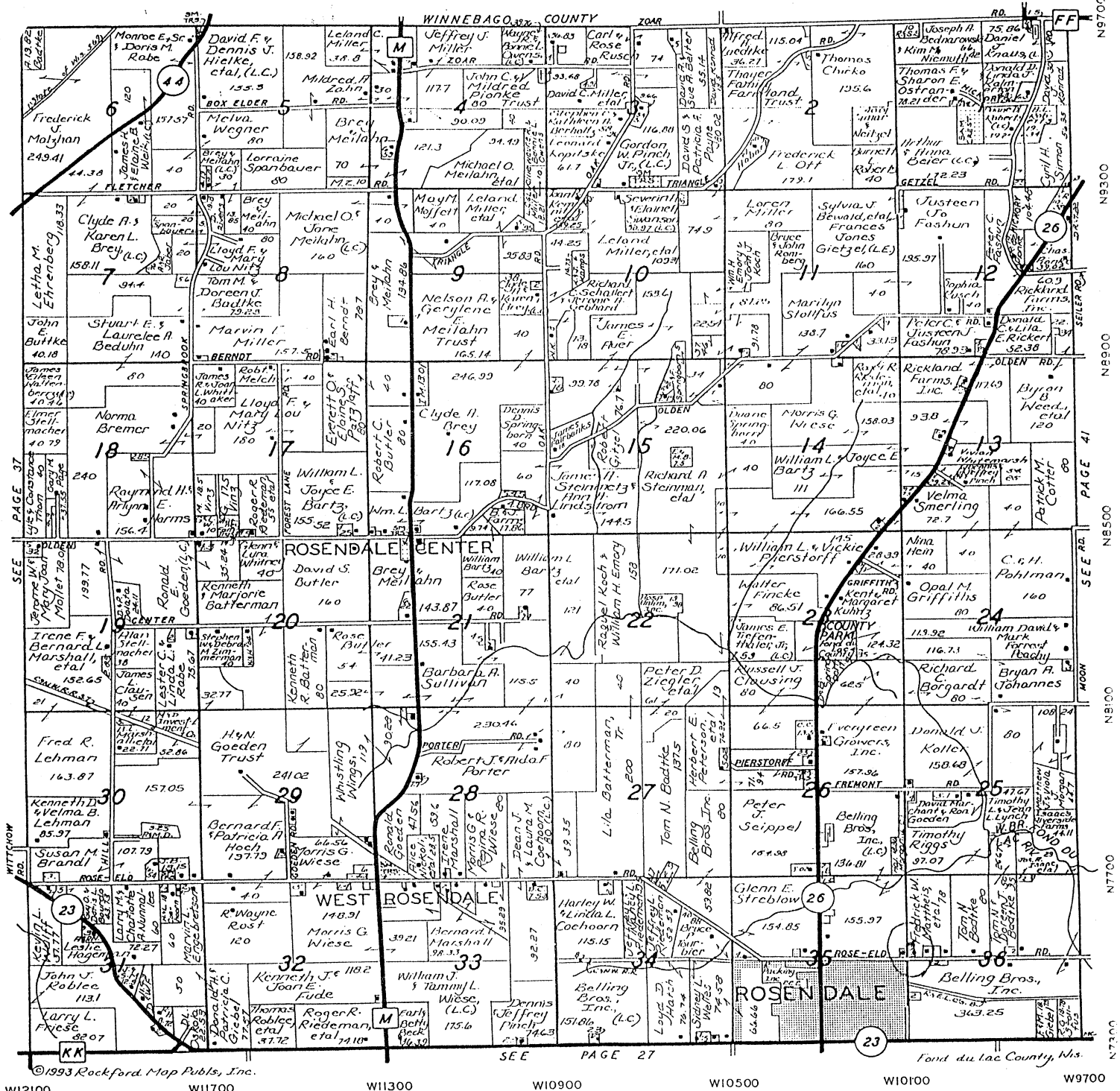


South line of the NW $\frac{1}{4}$ , Section 36-16-15
