



AN ORDINANCE TO ANNEX TERRITORY LOCATED IN THE TOWN OF BUENA VISTA, RICHLAND COUNTY, WISCONSIN TO THE VILLAGE OF LONE ROCK

The Village Board of the Village of Lone Rock, Richland County, Wisconsin, do ordain as follows:

That this ordinance is enacted in accordance with Section 66.021(12) of the Wisconsin Statutes for the purpose of annexing the below described territory which is contiguous to the Village of Lone Rock:

A part of the East Half (E $\frac{1}{2}$) of the Northeast Quarter (NE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Twelve (12), Township Eight (8), North Range Two (2) East, Richland County, Wisconsin, described as follows:

Commencing at a point on the East line of Section Twelve (12), forty (40) rods South from the Northeast corner of said section, thence West parallel with the South line of said section forty (40) rods, thence North parallel with the East line of said section to Wisconsin State Highway 14, thence East along said highway to the East line of said section forty (40) rods, thence South along the East line of said section to the place of beginning.

Beginning at a point that is forty (40) rods South of the Northeast corner of the Northeast Quarter of the Northeast Quarter, thence West sixteen (16) rods, thence South to the South line of said Northeast Quarter of the Northeast Quarter, thence East to the Southeast corner, thence North on the East boundary thereof, to the point of beginning, and containing approximately four (4) acres more or less, all in Section Twelve (12), Township Eight (8) North Range Two (2) East, Richland County, Wisconsin.

Said parcel contains something less than 40 acres and is subject to all easements and rights-of-way of record.


That this territory was the subject of a petition for direct annexation signed by all of the owners of the real property in such territory (there being no residents in said territory) and is being detached from the town of Buena Vista, Richland County, Wisconsin.

That this territory shall be zoned industrial and added to the Village of Lone Rock industrial park.

Effective date: This being an annexation ordinance based on unanimous approval of owners pursuant to Section 66.021(12) of the Wisconsin Statutes, there are no notice requirements and consequently this ordinance shall take effect on the day after its adoption by a two-thirds vote of the Village Board of Lone Rock.

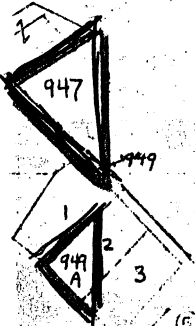

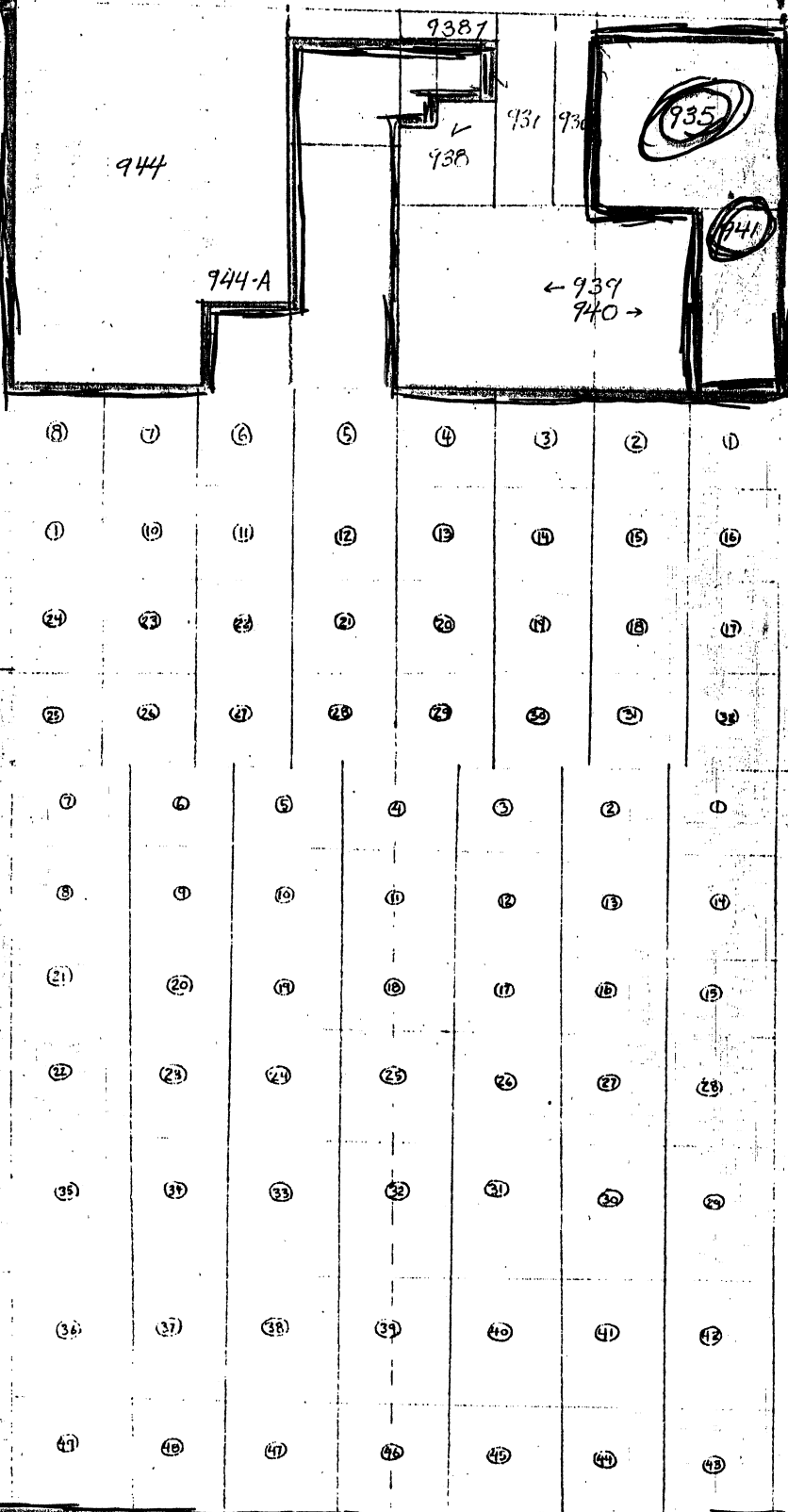
