ORDER OF THE CIRCUIT COURT IN THE MATTER OF THE
INCORPORATION OF THE VILLAGE OF PLAINFIELD

On reading and filing the application of the above named parties and on the production of the survey and map of the territory duly verified as required by law and on the presentment of the census of the inhabitants of said territory duly verified as required by law and on due proof of publication of the notice of this application as required by law and on due proof that the survey map and census were left and kept for examination at the place of business of a resident of said territory for the space of five weeks from the date of the first publication of the notice herein and it appearing to the satisfaction of the court that the survey and census of said territory are true and correct and that all the requirements of the statute have been complied with now on motion of M.M.Gillet, attorney for the said petitioner it is hereby ordered that the following described territory to-wit: Commencing at the one fourth post on range line between ranges 8 & 9, East Township 20 North on the East side of section 12, thence south along the range line between ranges 8 & 9, one mile to the one fourth post on said line being the quarter post on the East side of section 13, thence west along the quarter line one and one fourth mile thence north along the eighth line across sections 14 & 11 one mile until said line intersects the one fourth line running East and west across section 11, thence East along the one fourth line across sections 11 and 12 one mile and one fourth to the place of beginning, and situate lying and being in sections 11, 12, 13, & 14, Township 20 North of range Eight (8) East, town of Plainfield, Waushara County, Wisconsin shall be an incorporate village by the name of Plainfield if the electors thereof shall assent there to as provided by the revised statute of the state of Wisconsin and it is further ordered that W.W.Beach, B.B.Borden and W.B.La Selle, residents of such territory be and are hereby appointed to perform the duties of inspectors of election as required by chapter 40, revised statutes of Wisconsin.

Waushara County) surveyor and has been for 20 years and more last part.

That his residence is in Pine River, Waushara County, Wisconsin, that he has made a survey of the village of Plainfield with the view of the incorporation thereof that such survey commenced at the fourth post on range line between ranges Eight and Nine East township Twenty 20 North on the east side of section Twelve from that point I ran a line South along the range line between ranges 8 and 9, one mile to the fourth post on said line being the quarter post on East side of section 13, thence west along the quarter line one and one fourth miles at which place I set a post, thence north along the Eighth line across sections 14 and 11 one mile till said line intersects the one fourth line running East and West across section eleven at which point I set a post, thence East along the one fourth line across sections 11 & 12 one mile and one fourth to the place of beginning that said tract of land contains Eight hundred acres according to government survey, that such survey is a true and accurate and correct survey of the proposed village and was made the 27 & 28 days of June A.D. 1882, that the map hereto annexed is a true and accurate map of the territory proposed to be incorporated & such map is made from the survey aforesaid, and further deponent, saith not.
