

*Waukesha County*

All of Section 9; all the East 1/2 of Section 8; Southeast 1/4 of Section 5, West 1/2 of Section 8, South 1/2 of Section 10, North 1/2 of Section 15, Northeast 1/4 of Section 16, Town 7 North, Range 19 East, Town of Pewaukee, Waukesha County, Wisconsin, bounded and described as follows:

Commencing at the North 1/4 corner of Section 9; thence East along the North line of said section to a point, said point being North 116.00 feet and South 75°22' East, 338.48 feet from said North 1/4 corner; thence North 85°03' East, 151.20 feet; thence North 10°32' East, 180.00 feet; thence North 62°02' West, 217.60 feet to the East line of C.T.H. "J"; thence North 27° 58' East, 125.00 feet along said line; thence South 62°02' East, 367.01 feet; thence South 10°32' West, 204.63 feet to the North line of Section 9; thence East along said line to the Northeast corner of Section 9; thence South along the East line of Section 9 to a point, said point being 297.05 feet North of the North line of the C.M. St. P. & Pac. RR.; thence East 2746.98 feet to the South 1/4 line of Section 10; thence North, 1072.27 feet along said line to the South line of S.T.H. "190"; thence East along said road line, 715.12 feet; thence North to a point on the East 1/4 line of Section 10; thence East along said line, 617.63 feet to the East 1/16 line of Section 10; thence South along said 1/16 line to the North line of the C.M. St. P. & Pac. RR.; thence Northwesterly along said R.R. line to the South 1/4 line of Section 10; thence South on said 1/4 line to the intersection of said 1/4 line and the centerline of C.T.H. "88"; thence Northwesterly along said centerline, 793.54 feet to the Southeast corner of lands described in Document No. 423345, Waukesha County records; thence North 00°33'18" West along Easterly line of said lands, 188.13 feet; thence North 61°50'48" West along Northerly line of said lands, 132.00 feet to the Northwesterly corner of said lands; thence South 00°33'18" East along Westerly line of said lands, 188.13 feet to the centerline of C.T.H. "88"; thence Northwesterly along said road centerline to the Southeast corner of lands described in Document No. 425882, Waukesha County Records; thence North 01°53' East along the Easterly line of said lands, 479.40 feet to the South line of Section 10; thence West along said South line to a point, said point being 890.93 feet East of the Northwest corner of Section 15; thence South 0°33'45" East, 209.68 feet to the centerline of C.T.H. "88"; thence Northwesterly and Westerly along said road centerline to the centerline of the Pewaukee River; thence generally in a Southerly direction, along the meandering centerline of said river, to the Southwest corner of the "River Hills Park" Subdivision; thence West along the South line of said subdivision to the Southwest corner of said Subdivision; thence North along the West line of said subdivision to the South line of Section 9; thence West along said line

to the East line of the West 1/2 of the Northeast 1/4 of the Northwest 1/4 of Section 16; thence South along said East line to North 1/16 line of Section 9; thence West along said 1/16 line to the West line of Section 16; thence North along said West line to the Southeast corner of Section 8; thence West along the South line of Section 8 to the South 1/4 corner of Section 8; thence Northwesterly to a point, said point being at the intersection of the West line of Lot 11 of "Kopmeier's Subdivision" with the North shore of Pewaukee Lake; thence North along the said West line extended Northerly to the South right-of-way line of the C.M. St. P. & P. Railroad; thence Westerly along said right-of-way line to its intersection with the West line extended Southerly of the lands described in Volume 848, page 340, Document No. 523852 of Deeds, Waukesha County Records; thence Northerly along the West line of said lands and extension thereof to its intersection with the West line, extended Southerly, of lands described in Volume 495, page 447 of Deeds, Waukesha County records; thence Northerly along the West line of said lands and extension thereof, to the intersection of the centerline of C.T.H. "JJ"; thence Southeasterly along said road centerline to the Westerly line of lands described in Volume 840, Page 437, Document No. 518343 of Deeds, Waukesha County Records; thence Northeasterly along the Westerly line of said lands, 400.88 feet to the North line of Section 8; thence East along said North line, 434.03 feet to the North 1/4 corner of Section 8; thence continuing East along the North line of Section 8 to the centerline of C.T.H. "KF"; thence Northerly along said centerline, 649.15 feet; thence North 89°28' East, 892.34 feet to the East line of Section 5; thence North 0°32' West along said line, 66 feet; thence South 89°28' West, 897.29 feet to the centerline of C.T.H. "KF"; thence Northerly along said centerline, 586.94 feet to the South line of U.S.H. "16"; thence Southeasterly along said line to the East line of Section 5; thence South along said line, 244.95 feet; thence East along the South line of U.S.H. "16", 660.55 feet; thence Southeasterly along said road line, 706.10 feet; thence South along said line, 425.72 feet; thence East along said line 66.00 feet; thence South along said line, 66.00 feet to the North line of Section 9; thence East along the North line to the North 1/4 corner of Section 9, the place of beginning.
