ROBERT C. ZIMMERMAN SECRETARY OF STATE

The Village Board of the Village of Pewaulce, Wisconsin do ordain as follows:

SECTION 1. That Section 1.15 of the Municipal Code of the Village of Pewaukee entitled "Registry of Electors" is created to read as follows:

1.15 Registry of Electors.

Pursuant to Wisconsin Statute 6.27, registration for all elections in the village shall be required.

SECTION 2. Should any section, clause or provision of this ordinance be declared by the Courts to be invalid, the same shall not effect the validity of the ordinance as a whole or any part thereof, other than the part so declared to be invalid.

SECTION 3. All ordinances or parts of ordinances in conflict with any of the provisions of this ordinance are hereby repealed.

SECTION 4. This ordinance shall take effect and be in full force from and after the date of its passage and publication according to law.
