## VILLAGE OF HARTLAND ORDINANCE NO. 304

## AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF HARTLAND, WISCONSIN

The Village Board of the Village of Hartland, Wisconsin do ordain as follows:

SECTION 1. In accordance with Section 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the Village Clerk on the 30th day of March, 1978, constituting all of the owners of the real property hereinafter described, and all of the electors residing therein, the following described territory in the Town of Delafield, Waukesha County, Wisconsin, is annexed to the Village of Hartland, Wisconsin:

All that part of the Southeast Quarter (SE<sup>1</sup>/<sub>4</sub>) of Section 3, Town 7 North, Range 18 East, Town of Delafield, Waukesha County, Wisconsin, bounded and described as follows; Beginning at the northeast corner of said Southeast Quarter (SE<sup>1</sup>/<sub>4</sub>), said point being on the Corporate Limits of the Village of Hartland; thence South 00 degrees 21'45" East along the east line of said Southeast Quarter (SE1/4), center line of C.T.H. "HE," Maple Avenue, and Corporate Limits, 1788 feet; thence North 82 degrees 19'45' West 1358 feet more or less to the center line of C.T.H. "E," Cottonwood Avenue; thence South 00 degrees 22'59' East along the center line of C.T.H. "E," Cottonwood Avenue, 282 feet more or less to an existing fence line from the West; thence northwesterly along said fence line 1295 feet more or less to the west line of said Southeast Quarter (SE1/4) and Corporate Limits; thence northerly along said west line and Corporate Limits 1860 feet more or less to the center of said Section 3; thence North 89 degrees 33'04" East along the north line of said Southeast Quarter (SE14) and Corporate Limits 2640 feet more or less to the place of beginning; containing 106 acres of land more or less.

SECTION 2. From and after the date of this Ordinance the territory described in Section 1 shall be a part of the Village of Hartland for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Hartland.

SECTION 3. The above territory shall be zoned A-1, Agricultural District, pursuant to the authority granted in Section 66.021 (7) of the Wisconsin Statutes and pursuant 17.07(5) and 17.24(1) of the Municipal Code of Hartland, Wisconsin.

**SECTION 4.** The annexed territory is hereby made a part of the Village of Hartland, and is annexed for all municipal puposes and subject to all of the laws governing the same.

SECTION 5. The Village limits of the Village of Hartland, Wisconsin, are hereby changed and enlarged so as to include the real estate described in Section 1 of this ordinance, and the official map is amended to include said real estate.

SECTION 6. Should any section, paragraph, sentence, clause or phrase of the ordinance be declared unconstitutional or invalid for any reason, the remainder shall not be affected thereby.

SECTION 7. All ordinances or parts of ordinances inconsistent with or contravening the provisions of this ordinance are hereby repealed.

SECTION 8. This ordinance shall be in full force and effect after its passage and publication as provided by law.
