

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF MARATHON CITY,
MARATHON COUNTY, WISCONSIN

WHEREAS, a petition for direct annexation has been duly filed, signed by all of the owners of and electors residing in the following described territory requesting annexation to the Village of Marathon City, and

WHEREAS, said petition has been duly referred to the Department of Local Affairs and Development of the State of Wisconsin,

NOW, THEREFORE,

The Village Board of the Village of Marathon City, Marathon County, Wisconsin, do ordain as follows:

SECTION 1: Territory Annexed. In accordance with Section 66.021 of the Wisconsin Statutes of 1969, and said petition for direct annexation filed with the Clerk of the Village of Marathon City on the 1st day of July, 1971, signed by all of the electors residing in the territory and the owners of all the land in the territory, the following described territory, heretofore lying in the Town of Marathon, Marathon County, Wisconsin, is annexed to the Village of Marathon City, Marathon County, Wisconsin:

That part of the Southeast quarter ($SE\frac{1}{4}$) of the Southeast quarter ($SE\frac{1}{4}$), Section Six (6), Township Twenty-eight (28) North, Range Six (6) East, described as follows:

Commencing at the Southwest corner of said $SE\frac{1}{4}$ of $SE\frac{1}{4}$; thence running East to a point 179 feet East of the East line of East Street which is also the point of beginning of the parcel to be described; thence North to the South line of the Chicago & Northwestern Railway right of way; thence Westerly along the South line of said right of way to a point 100 feet East of the West line of said $SE\frac{1}{4}$ of $SE\frac{1}{4}$; thence South to the South line of said $SE\frac{1}{4}$ of $SE\frac{1}{4}$; thence East along the South line of said $SE\frac{1}{4}$ of $SE\frac{1}{4}$ to the point of beginning.

SECTION 2: From and after the date of adoption of this Ordinance, the territory hereinbefore described shall be a part of the said Village of Marathon City for any and all purposes provided by law and all persons residing or coming into or within said territory shall be subject to all ordinances, rates and regulations governing said Village of Marathon City.

SECTION 3: Temporary Zoning Classification.

(a) The said territory hereinbefore described is temporarily designated to be a part of the following District of the Village of Marathon City for zoning purposes:

Special Residential District.

(b) An amendment to the zoning ordinance setting forth permanent classification of said annexed parcel shall be acted upon by the Village Board no later than December 15, 1971.

SECTION 4: Effective Date. This Ordinance shall be in full force and effect upon its adoption and publication as provided by law.

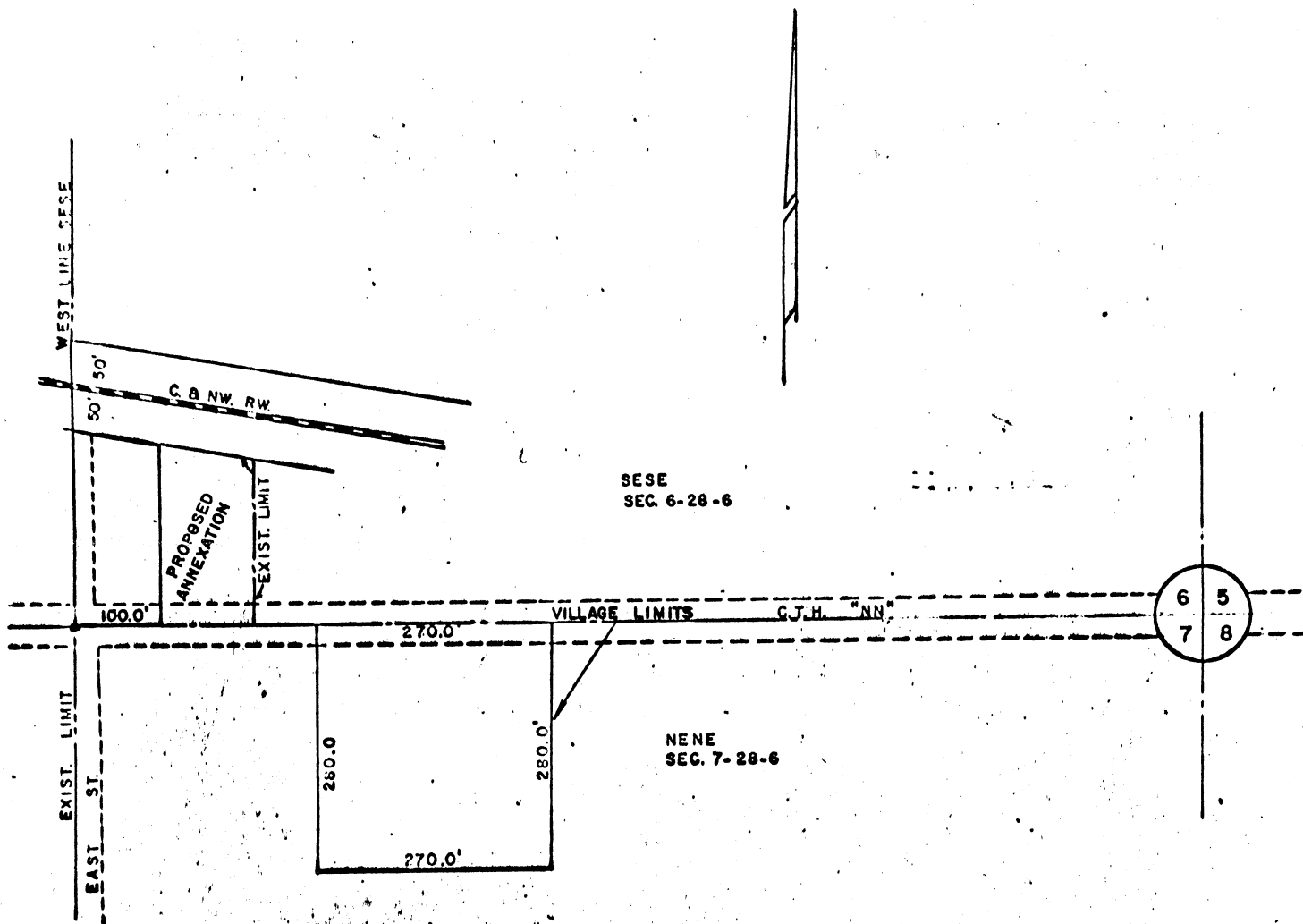
