## AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF MARATHON CITY, WISCON

The Village Board of the Village of Marathon City, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with s. 66.021 of the Wisconsin Statutes of 1991, and the petition for direct annexation filed with the village clerk on the 1<sup>st</sup> day of June, 1998, signed by the owner of all the land in the area of the territory, the following described territory in the Town of Cassel, Marathon County, Wisconsin, is annexed to the Village of Marathon, Wisconsin:

Lots 1, 2, and 3 in the SE1/4 SW1/4, Section 1, T 28 N, R 5 E, Town of Cassel, Marathon County, Wisconsin to wit:
Commencing at the South Quarter corner of said Section 1; N
1°31'13" W 532.92 feet to the point of beginning; N 0°36'47" E
784.03 feet; N 89°22'36" W 595.06 feet; S 6°34'38" W 584.51 feet; S 7°17'35" E 307.52 feet; N 80°09'36" E 367.69 feet; thence along the arc of a curve concave to the south whose radius is 2894.79 feet, whose central angle is 5°02'09" and whose chord bears N 82°40'48" E 254.34 feet to the point of beginning. Includes all of Lot 1 CSM 9149-36-152. Subject to the publics' rights to the waters of the Big Rib River, if any.

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1. shall be a part of the Village of Marathon City for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Marathon City.

#### Section 3. Zoning Classification.

(a) The territory annexed to the Village of Marathon City by this ordinance is designated to be part of the following district of the Village for Zoning purposes and subject to all provisions of Ordinance No 10. of the Village of Marathon City entitled "PLANNING AND ZONING" relating to such district classifications and to zoning in the Village:

R-1 Single Family Residential Use District

(b) The boundaries of these designated districts are established as shown on the map filed in the office of the village clerk entitled "Supplemental District Map, Marathon City, Wisconsin", dated April 9, 1998.

**Section 5.** Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

**SECTION 6.** Effective Date. This ordinance shall take effect upon passage and publication as provided by law.
