



# INCORPORATION OF VILLAGE OF IOLA

In Circuit Court Waupaca County:

In the matter of the application for the incorporation of the village of Iola Wisconsin.

At a special term of the Circuit Court for Waupaca County

began and held at the Court House in the Village of Wautoma Waushara County Wisconsin on the First Tuesday being the 3rd day of May A.D. 1892

On reading and filing the application herein for the incorporation of the territory hereinafter described and the Court being satisfied that such survey and census therein contained are correct and that all the requirements of the statutes have been complied with, and that all the lands embraced in such territory should be included in the proposed Village and that such territory contained at the time such census was taken the population in number and in proportion to the quantity of land ~~contained~~ therein as required by section Eight hundred fifty four of the revised statutes of the State of Wisconsin and acts Amendatory thereto, Now therefore on motion of Paul H. Sanborn Attorney for said applicants; It is ordered that the following described territory situated in the towns of Iola and Scandinavia in the County of Waupaca and State of Wisconsin to-wit:- Bounded by a line commencing at the South West corner of the North East quarter of the North West quarter of section two in town Twenty three North and Range Eleven East, and running thence North Ninety seven and forty five one hundredths chains to the North West corner of the North East quarter of the North West quarter of section thirty five in town twenty four North of Range Eleven East, thence East Forty chains to the North East corner of the North West quarter of the North East QUARTER of said section thirty five, thence South twenty chains, thence East forty chains to the North East corner of the South West quarter of the North West quarter of section thirty six in town twenty four North and Range Eleven East, thence South on the one eighth line seventy seven and twelve and one half hundredths chains to the South East corner of the North West quarter of the North West quarter of section one in town twenty three North and Range eleven East, thence West on the one sixteenth line eighty chains to the place of beginning, be and the same hereby is declared

to be an incorporated Village by the name of Iola in the County of Waupaca & State of Wisconsin, provided however that the electors thereof shall assent thereto as provided by law, and it is further ordered and directed that O.G. Frogner, S. P. Jameson and Jacob Wipf all residents of the territory heretofore described be and perform the duties of inspectors of election as required of them by Chapter forty of the Revised Statutes of the State of Wisconsin and acts amendatory thereto
