### AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF BONDUEL, WISCONSIN

The Village Board of the Village of Bonduel, Wisconsin, do ordain as follows:

**SECTION 1.** Territory Annexed. In accordance with sec. 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the village clerk on the  $20^{th}$  day of August, 1999; signed by a number of electors residing in the territory equal to at least the majority of votes cast for governor in the territory at the last gubernatorial election and the owners of at least ½ of the land in area in the territory, the following described territory in the Town of Hartland, Shawano County, Wisconsin, is annexed to the Village of Bonduel, Wisconsin:

**SECTION 2.** Effect of Annexation. From and after the date of this ordinance the territory described in section 1 shall be a part of the Village of Bonduel for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Bonduel.

**SECTION 3.** Temporary Zoning Classification. (a) Upon recommendation of the plan commission, the territory annexed to the Village of Bonduel by this ordinance is temporarily zoned as follows, pursuant to sec. 66.021 (7)(a) of the Wisconsin Statutes:

- (a) Industrial District
- (b) The plan commission is directed to prepare an amendment to the zoning ordinance setting forth permanent classifications and regulations for the zoning of the annexed area and to submit its recommendations to the board not later than October 13, 1999.

**SECTION 4.** Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

**SECTION 5.** Effective Date. This ordinance shall take effect upon passage and publication as provided by law.
