

In re-application for the (incorporation of the) June Term to wit: Village of Belleville. (June 27th,1892.

At the regular term of the Circuit Court for Dane County, held at the Court House in the City of Madison begun and holden on these 27th day of June A.D.1892. Present and presiding Hon. Robert Seibecker Judge,

The application of J.M. Williams, H.E. Stroy and thirty three others, inhabitants and tax payers of the Town of Montrose, Dane Co. and of the premises hereinafter described for an Order incorporating that part of said town known and described as the So of Sec. 34, Town 5 North, Range 8 East, as the Village of Belleville, coming on to be heard before the Court and after reading and fileing the notice of application, Proof of Publication of the same, petition, survey and census and accompaning documents, and the Court being satisfied after such hearing, of the correctness of such survey and census, and that notice of this application was duly given, and that all the other requirements of the Statute have been complied with, that the lands described in said survey should be embraced within that limits of said Village; that the interests of the inhabitants will be promoted to such incorporation; and that such territory herein i included, contained at the time such sensus was taken, April 22nd, 1892, Three hundred and fourteen bona fide inhabitants;

On motiom of C.E.Estabrook Atty. for said petitioners,

described premises, to wit: The South half(\frac{1}{2}) of Sec. 34, Township 5 North and Range 8 East, and more particularly described by matter metes and bounds as follows; Commencing at the South East corner of Sec. 34, Township 5 North and Range 8 East, and thence running North along the Sec. line, One Hundred and Sixty Rods (160); thence West along the center of said Section, a distance of Three Hundred and Twenty Rods, (320); thence South along the West line of said Sectiona distance of One Hundred and Sixty Rods (160); themes to the Sotuh West corner of said Section; thence East along the South line of said Section, Three Hundred and Twenty Rods (320); to the place of beginning, be an incorporated Village by the name of "Belleville" if the electors thereof shall accent thereto at an election to be held in said territory at which said question of incorporation shall be submitted.

It is further ordered that J.M. Williams, H.E. Story and C.W. Derrickson electors of said Town be and they are hereby authorized and directed to perform the duties of inspectors and to conduct such election.



Whereas by an Order of the Circuit Court of Dane County, made on the 28th day of June A.D.1892. the undersigned were authorized to hold an election within the limits of the proposed Village of Belleville being the South half of Section 34, Town 5 North, Range 8 East, to determine by an election whether said district should become incorporated as the Village of Belleville:—
