

VILLAGE OF BELLEVILLE, DANE COUNTY, WISCONSIN  
CORPORATE LIMITS DESCRIPTION

The following parcels of land located in Section 34, T5N, R8E, Dane County, Wisconsin, and in Section 3, T4N, R8E, Green County, Wisconsin, and more particularly described as follows:

Commencing at the Southeast corner of Section 34, Township 5 North and Range 8 East; thence West along the South boundary of said section to the northeast corner of Section 3, T4N, R8E; thence S. 2° 26' East along the East line of said Section 3, 977 feet to the Southeast corner of fractional Northeast  $\frac{1}{4}$  of Northeast  $\frac{1}{4}$  of said section 3; thence North 88°-49' W, 3416.9 feet; thence North 906.0' to the Southeast corner of Lot 1, Block 7, Wheelright's Second Addition to the Village of Belleville, and on the line between said Dane and Green Counties, Wisconsin; thence West along the southern boundary of Section 34 to the Southwest corner of Section 34; thence continuing West along the southern boundary of Section 33, a distance of 324.1 feet more or less to the West line of vacated Plat of Fairview Heights; thence continue West along the Southern boundary line of said Section 33, a distance of 66 feet; thence N. 0° 19' W. 462.9 feet; thence South 89° 58' E. 66 feet; thence N. 0° 19' W. 137.6 feet; thence S. 89° 58' E. 326.9 feet to East line of SE $\frac{1}{4}$  SE $\frac{1}{4}$  of said Section 33; thence North approximately 502.5 feet to the centerline of Highway 69; ~~thence easterly following the centerline of said Highway 69 until it intersects the West boundary of Section 34~~; thence North along the western boundary of Section 34 to the East and West quarter line of Section 34; thence S. 89°-43' East 953 feet along the East and West quarter line of said Section 34; thence North 158.5 feet; thence North 42° 30' West 290.3 feet; thence North 7° 38' West 277.5 feet; thence South 89° 30' West 118.5 feet to an end fence post on the South bank of the Sugar River; thence North to the North bank of said river; thence following the bank of said river northerly and easterly to a point on Sugar River which is 1331.72 feet West of the centerline of S. T. H. 69; thence North parallel to the centerline of S. T. H. 69 to the North line of said Section 34 at a point 1331.72 feet East of the Northwest corner of said Section 34; thence East 1331.72 feet to the centerline of S. T. H. 69; thence Southerly on the centerline of S. T. H. 69 to a point which is 770.30 feet Southerly from the North line of said Section 34; thence N 89°-41' East 825.8 feet to the West line of the Illinois Central R.R.; thence S 3°-16' West along the West right-of-way line of the Illinois Central R.R. to the East and West  $\frac{1}{4}$  line of Section 34; thence East along the East and West  $\frac{1}{4}$  line of said Section 34 to the East boundary of said Section 34; thence South 2,640 feet to the point of beginning.
