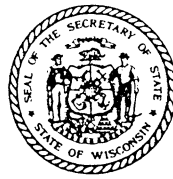

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE  
OF ROTHSCHILD, MARATHON COUNTY, WISCONSIN  
(Richey)

WHEREAS, A Petition for Annexation by Unanimous Consent has been duly filed, signed by the electors and the owners of the real property in the following described territory requesting annexation to the Village of Rothschild and,

WHEREAS, Said Petition has been duly referred to the Plan Commission of the Village of Rothschild and to the Department of Local Affairs and Development of the State of Wisconsin and recommendations having been made to the Village Board by both bodies;

NOW, THEREFORE, The Village Board of the Village of Rothschild, Marathon County, Wisconsin, do ordain as follows:

Section 1: Territories Annexed. In accordance with Section 66.021 of the Wisconsin Statutes and said Petition for Annexation by Unanimous Consent filed with the Clerk of the Village of Rothschild on the 19th day of October, 1988 signed by the electors residing in, and the owners of the real property in said territory; the following described territory heretofore lying in the Town of Weston, Marathon County, Wisconsin, is annexed to the Village of Rothschild, Marathon County, Wisconsin:

Lot two (2) and Lots five (5) through eleven (11), inclusive, in Block one (1) of Richey's Addition, and Lots one (1) through eight (8), inclusive, in Block two (2) of Richey's Addition, in the Town of Weston, including the adjoining South half of Lemke Road, all of Richey Street, the adjoining North half of Military Road, and the adjoining East half of Urban Street.

Section 2: From and after the date of adoption of this Ordinance, the territories hereinbefore described shall be a part of the said Village of Rothschild and for any and all purposes provided by law and all persons residing or coming into or within said territory shall be subject to all ordinances, rates and regulations governing said Village of Rothschild.

Section 3: Temporary Zoning Classification: The said territory hereinbefore described is temporarily designated to be a part of the First Residence District of the Village of Rothschild for zoning purposes.
