I, Ariel J. Nolan, Village Clerk of the Village of Waunakee, County of Dane, State of Wisconsin, DO HEREBY CERTIFY that the corporate boundaries of the said Village have been altered within the previous 12-month period ending December 1, 1975, and that the following description is the present limits of the said Village as of December 1, 1975:

Part of Sections 5, 6, 7, 8 and 9, Township 8 North, Range 9 East, Village of Waunakee, Dane County, Wisconsin, described as follows: Beginning at the quarter section corner between Sections 5 and 6; thence South along the Section lines to the Northeast corner of the Southeast 1/4 of the Southeast 1/4 of Section 6; thence West along the North line to the Northwest corner of said Southeast 1/4 of the Southeast 1/4; thence South along the West line thereof to a point 350.00 feet North of the South line of Section 6; thence West 347 feet; thence South 0° 19' East to the Section line between Sections 6 and 7; thence South 88° 53' West along said section line 823.20 feet; thence South 1° 50' East 528.00 feet; thence South 88° 53' West 70.30 feet; thence South 1° 50' East 230.00 feet; thence South 88° 53' West 94.70 feet to the North-South quarter section line of said Section 7; thence South along the North-South quarter Section line to the South 1/4 corner of Section 7; thence East along the South line thereof to the Southeast corner of Section 7; thence North along the East line to the quarter corner between Sections 7 and 8; thence East along the East-West quarter Section line of Section 8 a distance of 599.63 feet; thence South parallel with the West line of Section 8, a distance of 1650 feet; thence East parallel with the South line of said Section 8, a distance of 1055.0 feet; thence South to the South line of Section 8; thence East along the said South line to the Southeast corner of the West 1/2 of the Southeast 1/4 of Section 8; thence North along the East line of said West 1/2 of the Southeast 1/4 to the East-West quarter Section line of Section 8; thence East along said East-West quarter Section line to the Northeasterly right of way line of the Chicago Northwestern Railway; thence Southeasterly along said right of way line to the East line of Section 8; thence North along the East line of Section 8 to the 1/4 corner between Sections 8 and 9; thence East along the East-West 1/4 Section line of Section 9 to the center of said Section 9; thence North along the North-South 1/4 Section line to the North line of said Section 9; thence West along said North line to the Southeast corner of Section 5; thence North along the East line thereof to the East 1/4 corner of Section 5; thence West along the East-West quarter line of Section 5 to the 1/4 Section corner between Sections 5 and 6 and the point of beginning.

Also that part of the Northeast 1/4 of the Southeast 1/4 of Section 8 described as follows: Commencing at the intersection of the Southwesterly right of way of the Chicago-Northwestern Railway and the North line of said Northeast 1/4 of the Southeast 1/4; thence Southeasterly along said right of way line 50.0 feet to the point of beginning of this description; thence Southwesterly at right angles to said right of way line 63.0 feet to the Westerly side of Six Mile Creek; thence Southeasterly along said Creek 50.0 feet; thence Northeasterly 43.0 feet to the Westerly right of way line; thence Northwesterly along said right of way line 44.0 feet to the point of beginning.
