CERTIFICATE FOR REPORTING CORPORATE
LIMITS OF VILLAGE AFTER ALTERATION

I, Alice Kleine, Village Clerk of the Village of Deerfield, County of Dane, State of Wisconsin, DO HEREBY CERTIFY that the corporate boundaries of the said Village have been altered within the previous 12-month period ending December 1, 1973, and that the following description is the present corporate limits of the said Village as of December 1, 1973.

Part of Section 21, 22 and 28, Township 7 North, Range 12 East, Dane County, Wisconsin, described as follows: Beginning at the common corner of Sections 21, 22, 27 and 28, Township 7 North, Range 12 East; thence East along the South line of Section 22 a distance of 1330 feet; thence Northerly 1320 feet; thence Westerly 1328 feet to the West line of Section 22; thence Northerly along the Section line between Sections 21 and 22, a distance of 1321.5 feet to the East 1/4 corner of Section 21; thence West along the 1/4 section line of Section 21 a distance of 380.75 feet; thence Northeasterly parallel with the center line of Main Street in the Village of Deerfield, 270.00 feet; thence West 168.75 feet to the center line of Main Street; thence along the center line of Main Street North 12° 00' East 367.04 feet; North 8° 15' East 77.7 feet; North 4° 43' East 164.3 feet and North 1° 11' East 453 feet; thence North 89° 54' West 1212.4 feet; thence South 2° 52' West 1320.75 feet to the North line of the Southeast 1/4 of Section 21; thence West along said North line 1013.0 feet to the Northwest corner of the Southeast 1/4 of Section 21; thence South along the North and South 1/4 section line of Section 21 a distance of 2646 feet; to the North line of Section 28; thence continuing South along the North and South 1/4 section line of Section 28 a distance of 270.25 feet; thence West 150 feet; thence South 399.5 feet; thence East 150 feet to the North and South 1/4 section line; thence South along said line 506.05 feet; thence West 330 feet; thence South 125.0 feet to the North line of the Southeast 1/4 of the Northwest 1/4 of Section 28; thence West along the said North line to the Northwest corner of the Southeast 1/4 of the Northwest 1/4 of Section 28; thence South along the West line of the Southeast 1/4 of the Northwest 1/4 and of the Northeast 1/4 of the Southwest 1/4 of Section 28 to the Southwest corner of the Northeast 1/4 of the Southwest 1/4; thence East along the South line of Northeast 1/4 of the Southwest 1/4 and of the Northwest 1/4 of the Southeast 1/4 to the Southeast corner of the Northwest 1/4 of the Southeast 1/4; thence North along the East line of the Northwest 1/4 of the Southeast 1/4 to the Northeast corner thereof; thence East along the East-West quarter section line of said Section 28 to the East quarter corner thereof; thence North along the East line of Section 28 a distance of 2655.2 feet to the point of beginning. EXCEPT the following lands as described in Records 260, page 63, Dane County Registry: Commencing at the East quarter corner of Section 28; thence South 85° 49' West 2008.49 feet; thence South 57° 13' 25" West 420.59 feet to the point of beginning; thence South 1° 45' 45" West 680.63 feet; thence North 88° 14' 15" West 488.00 feet; thence North 1° 45' 45" East 680.63 feet; thence South 88° 14' 15" East 488.00 feet to the point of beginning.
