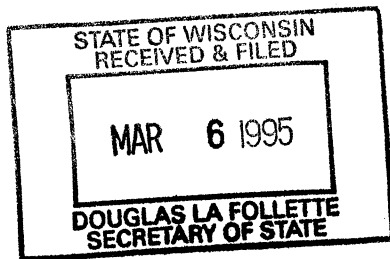

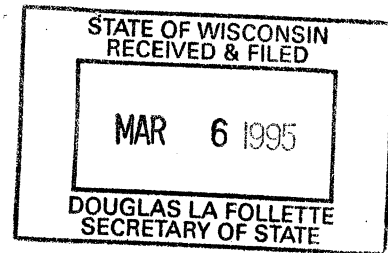

ORDINANCE 94-6
ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF
CADOTT FROM THE TOWN OF GOETZ

The Village Board of the Village of Cadott does ordain as follows:

WHEREAS, the Village Board of the Village of Cadott has purchased real property in the Town of Goetz for the Village's water supply and pursuant to section 66.025 of the Wisconsin Statutes, annexation of owned territory; and

WHEREAS, the Village Board of the Village of Cadott has reviewed the proposed annexation and finds same to be in the best interest of the Village of Cadott; and

WHEREAS, the Village Board of the Village of Cadott, Chippewa County, Wisconsin does ordain that the following described real property, now a part of the Town of Goetz, Chippewa County, Wisconsin is hereby detached from the said Town of Goetz and annexed to the Village of Cadott, Chippewa County, Wisconsin to wit:

Section 36, Township 29N, Range 7W, all that part of
the North $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ lying North of the
Yellow River. 29 acres


IT IS FURTHER ORDAINED, that the above described property be zoned and classified under the Zoning Ordinance for the Village of Cadott as "A" District pursuant to Section 10-2-41 of the Municipal Code of Ordinance for the Village of Cadott; and

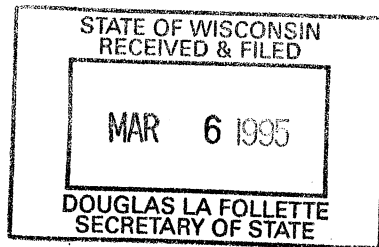
IT IS FURTHER ORDAINED, that the Village Clerk shall file with the Secretary of State five (5) certified copies of the ordinance, certificate and plat showing boundaries of territory attached and one copy with the Register of Deeds and one copy with the Clerk of the Cadott School District, signed by the clerk describing the territory so annexed and associated


population therein; and
