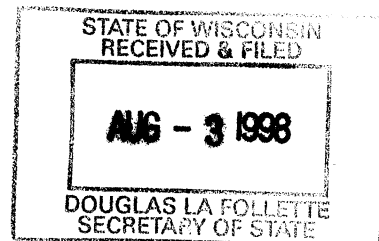

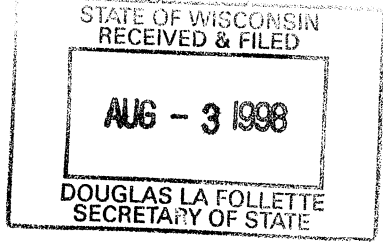

WHEREAS, the State of Wisconsin, Department of Development has been notified of such proposed annexation and has not objected thereto; and


WHEREAS, it appears that it is in the public interest to annex such real estate to the Village of Cambridge, Wisconsin;


NOW, THEREFORE, IT IS HEREBY ORDAINED that the real estate described as follows:
