

Description of Williams Bay Corporate Limits

I, Virginia Stenus, Village Clerk of the Village of Williams Bay, County of Walworth, State of Wisconsin, DO HEREBY CERTIFY that the corporate boundaries of the said Village have been altered within the previous 12-month period ending December 1, 1972, and that the following description is the present corporate limits of the said Village as of December 1, 1972:

Land lying and being in Sections 1, 11 and 12, T1N R16E, (Walworth Town) and Sections 5, 6 and 7, T1N R17E, (Linn Town) and Section 36, T2N R16E, (Delavan Town) Walworth County, Wisconsin, and being more fully described as follows, to wit: Beginning at the Northwest corner of said Section 6, being also the Northwest corner of Linn Town, running thence East along the North line of said Town 5243 feet, more or less to the Northeast corner of said Section; thence South on the Section line between Sections 6 and 5, T1N R17E, 880.5 feet; thence East 594 feet; thence South parallel with the Section line between Sections 6 and 5, 635.5 feet, thence West 33 feet to the West line of Johnston Road; thence South along the West line of Johnston Road 499.3 feet; thence West 561 feet to the Section line between Sections 5 and 6 aforesaid; thence South along the Section line between Sections 5 and 6 of T1N R17E, 1531.98 feet to a point in the North line of a public highway; thence N51°-23'E along the North line of said public highway 742.9 feet; thence South along the East line of Lot 1 of Cedar Point Subdivision 946.45 feet to the shore of Geneva Lake; thence Southwesterly along the shore 777 feet to the West line of said Section 5, T1N R17E; thence South 2328.38 feet more or less to a point in Geneva Lake; thence West to a point where the West line of Section 12, T1N R16E strikes the low water line on the North shore of Geneva Lake; thence Southwesterly along the shore line 265 feet more or less, to a point which is S36°-32'E 14 feet more or less from an iron pipe; thence N36°-32'W 14 feet more or less; thence continue N36°-32'W 933.46 feet; thence West 247.88 feet; thence N36°-32'W 41.07 feet; thence West 236.58 feet; thence N0°-21'W 629.23 feet to the North line of Section 11, T1N R16E; thence S89°-46'E

1334.85 feet along the North line of said Section 11 to the Northeast corner of said Section 11; thence North along the West line of Section 1, T1N R16E, 5604 feet, more or less, to the Northwest corner of said Section 1, T1N R16E, thence East along the North line of said Section 1, 3004 feet; thence North 630 feet to a point 30 feet South of the North line of the South $\frac{1}{2}$ of the South $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of said Section 36; thence West 426 feet to a point 30 feet West of the North-South $\frac{1}{4}$ Section line of said Section 36; thence North parallel to and 30 feet West of said North-South Section line 690 feet to the South line of the North $\frac{1}{2}$ of the Southwest $\frac{1}{4}$ of Section 36, T2N R16E; thence West along said South line 2610 feet more or less to the West line of Section 36; thence North along said West line 1320 feet more or less to the East-West $\frac{1}{4}$ Section line of said Section 36; thence East along said East-West $\frac{1}{4}$ Section line 2640 feet more or less to the North-South $\frac{1}{4}$ Section line of Section 36, T2N R16E; thence South along said North-South $\frac{1}{4}$ Section line 1980 feet more or less to the North line of the South $\frac{1}{2}$ of the South $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of said Section 36; thence East along said North line 2640 feet to the East line of said Section 36; thence South on said East line 660 feet to the place of beginning, and containing 1872.97 acres more or less.
