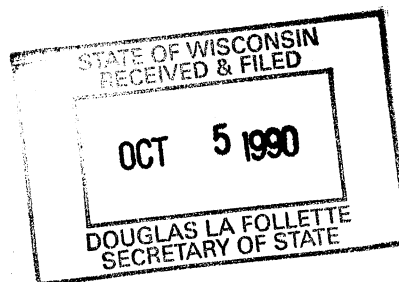

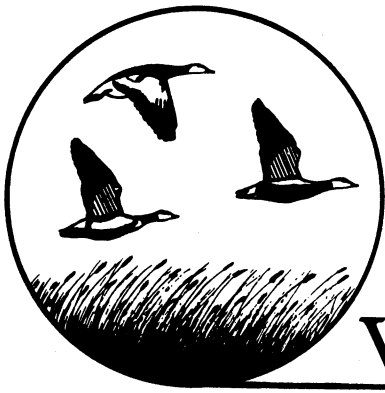

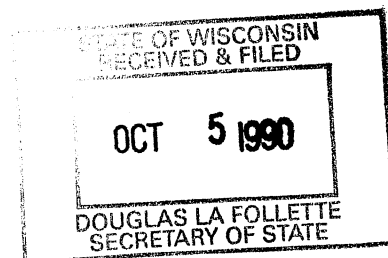

AN ORDINANCE ANNEXING LANDS FROM  
THE TOWN OF DUNN TO THE VILLAGE OF MCFARLAND

The Village Board of the Village of McFarland do ordain as follows:

Section 8.03 of the McFarland Municipal Code is hereby created to read as follows:

Section 1: Proper petition having been presented seeking annexation of the following property to the Village of McFarland, Wisconsin to-wit:

A parcel of land located in Section 2 and Section 11, Township 6 North, Range 10 East, Town of Dunn, Dane County, Wisconsin, more particularly described as follows:  
The West 1/2 of the South East Quarter of Section 2, Township 6 North, Range 10 East, and the North West Quarter of the North East Quarter of Section 11, Township 6 North, Range 10 East, Town of Dunn, Dane County, Wisconsin;

NOW, THEREFORE, the above described property is hereby annexed to the Village of McFarland.

Section 2: This ordinance shall take effect upon its passage and publication.

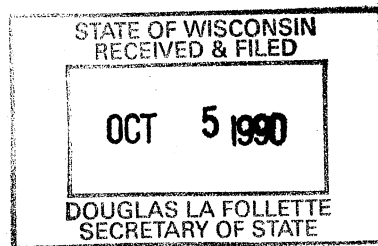
