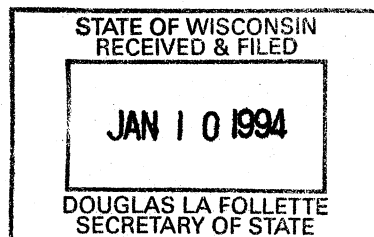

I, Mary Lou Hanson, Village Clerk of the Village of Exeland, Sawyer County, Wisconsin, pursuant to the provisions of Wisconsin Statutes sec. 66.021(8)(a), do hereby certify the boundaries of the Village of Exeland as of December 1, 1993, as follows:

Commencing at the Northwest corner of the NE1/4 SW1/4, Section 21; thence East along the North line thereof to the Northwest corner of the SE1/4 of Section 21; thence continue East along the North line thereof to the Northwest corner of the NW1/4 SW1/4, Section 22; thence continue East along the North line thereof to the Northeast corner thereof; thence South along the East line of the W1/2 SW1/4, Section 22, to the Northeast corner of the NW1/4 NW1/4, Section 27; thence continue South along the East line of the W1/2 NW1/4, Section 27 to the Southeast corner thereof; thence West along the South line of the W1/2 NW1/4 to the Southeast corner of the NE1/4, Section 28; thence continue West along the South line of said NE1/4 to the Northeast corner of the W1/2 NE1/4 SE1/4, Section 28; thence South along the East line of thereof to the Southeast corner thereof; thence West to the Southwest corner of the NW1/4 SE1/4, Section 28; thence North along the West line thereof to the Southeast corner of NW1/4, Section 28; thence West along the South line thereof to the Southwest corner thereof; thence North along the West line thereof to the Northwest corner thereof; thence East along the North line thereof to the Southwest corner of the E1/2 SW1/4, Section 21; thence North along the West line thereof to the point of beginning; All in Township 37 North, Range 7 West.

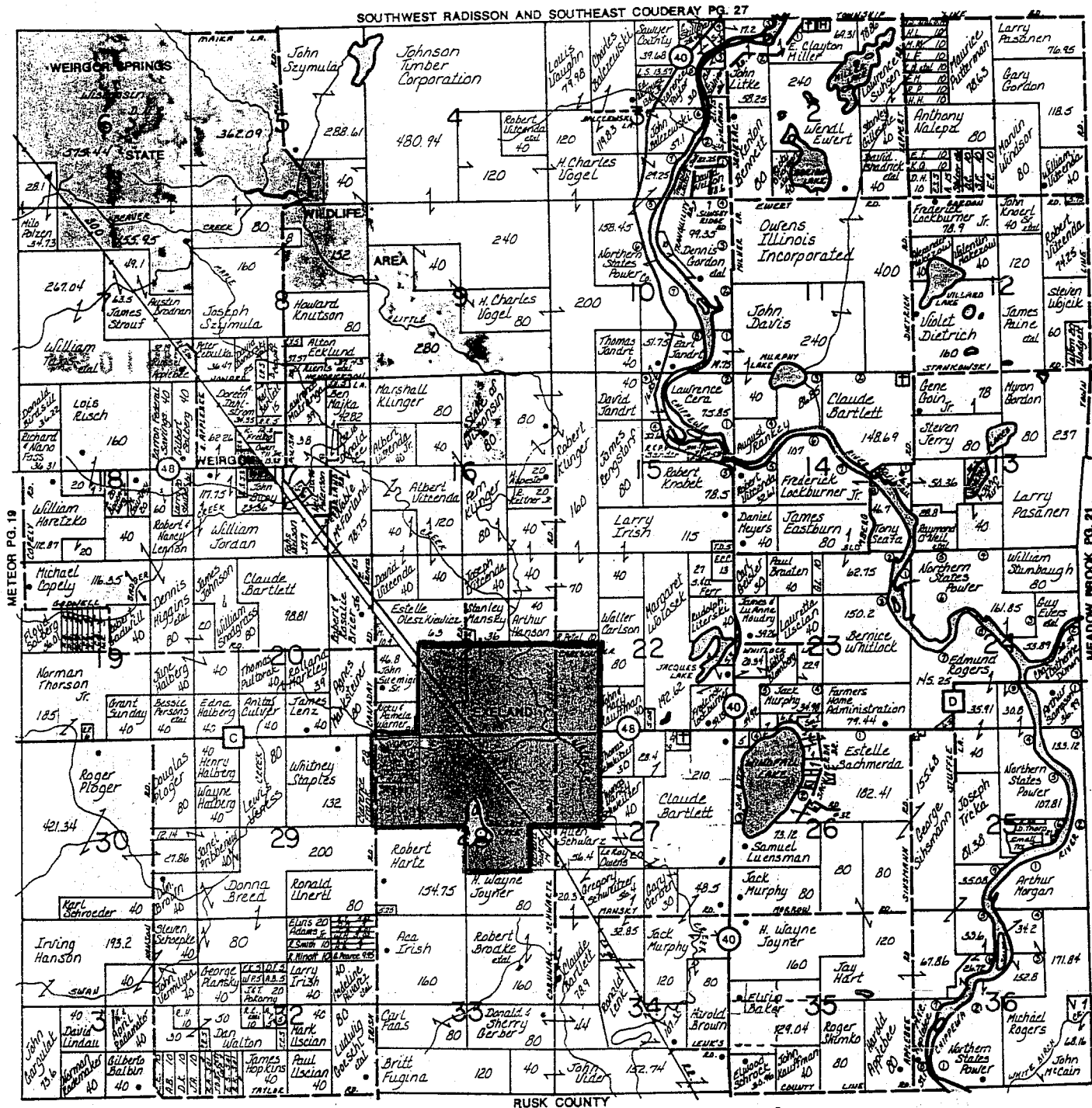
