Do hereby certify that the following described territory was detached from the Town of Buchanan, Outagamie County, and was annexed to the said Village of Combined Locks, by an ordinance adopted by the Village Board at a Regular meeting held Aug. 17, 1962.

All that part of Government lots two (2) and three (3) section twenty five (25) Township Twenty-one (21) North Range Eighteen (18) East in the Town of Buchanan, Outagamie County, Wisconsin described as follows:

Beginning at a point being Thirty feet (30) East of the Southeast corner of Lot one (1) Block Three (3) of Van Daalwyck Subdivision in the Village of Combined Locks, running thence South Two Hundred Sixty Four and Sixty five hundredths feet (264.65); thence West parallel to the South line of Block three (3) of aforesaid Subdivision Four Hundred Forty One (441); thence North Two Hundred Sixty Four and Sixty Five hundredths Feet (264.658) to the South line of Block three (3); thence east along said line to the place of beginning.

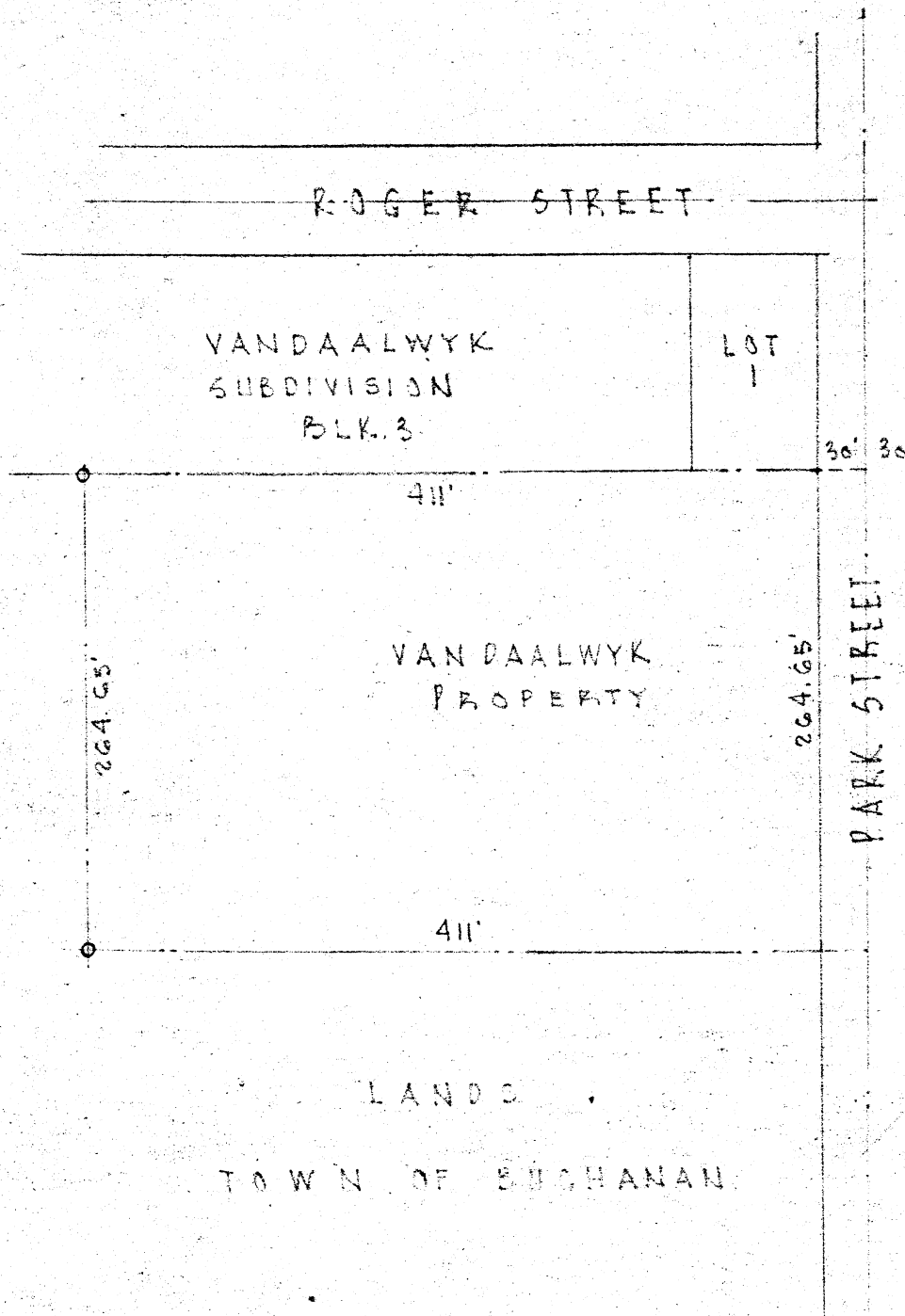

All that part of Government Lots Two (2) and Three (3) Section Twenty-five (25) Township Twenty-one (21) North, Range Eighteen (18) East in the Town of Buchanan, Outagamie County, Wisconsin described as follows: Beginning at a point in the center line of Park Street said point being Thirty Feet (30') East of the Southeast corner of Lot One (1) Block Three (3) of Van Daalwyk Subdivision in the Village of Combined Locks running thence South Two Hundred Sixty-four and Sixty-five Hundredths Feet (264.65'); thence West parallel to the South line of Block Three (3) of aforesaid Subdivision Four Hundred Forty-one Feet (441'); thence North Two Hundred Sixty-four and Sixty-five Hundredths Feet (264.65') to the South line of Block Three (3); thence East along said line to the place of beginning.
