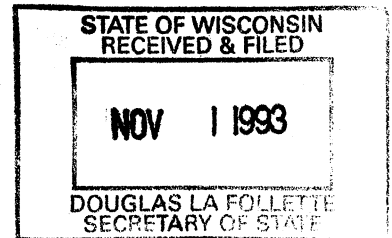

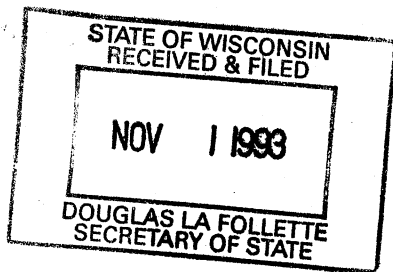

An Ordinance Annexing Certain Lands to the Village of Slinger, Washington County, Wisconsin.

WHEREAS, a Petition for Direct Annexation, together with a scale map of the area to be annexed, signed by all of the electors residing in the area to be annexed, and by the owners of all of the land area to be annexed, and

WHEREAS, a Petition for Direct Annexation of Lands to the Village of Slinger has been filed, and

WHEREAS, a proof of service of said Petition and map on the Town Clerk of the Town of Polk, Washington County, Wisconsin, has been filed, and

WHEREAS, a proof of mailing of said Petition and map to the Department of Administration, State of Wisconsin, has been filed, and

WHEREAS, said lands are contiguous to the Village of Slinger, and

WHEREAS, it has been determined that the area to be annexed does not constitute more than one square mile, and

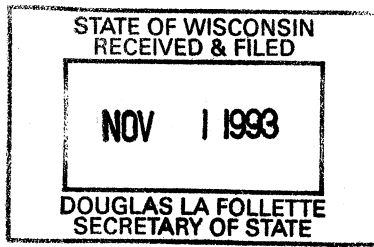
WHEREAS, it has been determined that by annexation of the area described in the Petition no town area will be created which is completely surrounded by the Village of Slinger.

NOW THEREFORE, the Village Board of the Village of Slinger, Washington County, Wisconsin, does ordain as follows:

SECTION I. The following described property. to-wit:

That part of the Southeast Quarter of the NORTHEAST Quarter (SE-1/4 NE-1/4) of Section Seventeen (17), Township Ten (10) North, of Range Nineteen (19) East, described as follows, viz:

Commencing at the East Quarter Corner of said Section 17; thence North 0 degrees 38 minutes West along the East line of said Section 17, 291.20 feet to the place of beginning of this description; thence North 0 degrees 38 minutes West, 484.00 feet; thence South 89 degrees 22 minutes West, 599.68 feet to a point on the North-Easterly right of way line of United States Highway No. 41; thence South 45 degrees 19 minutes 20 seconds East along said right of way line, 680.78 feet; thence North 89 degrees 22 minutes East, 120.94 feet to the place of beginning.
