ORDINANCE NO. 22-99

ORDINANCE AMENDING ORDINANCE No. 22-98 REGARDING ANNEXATION OF A PORTION OF THE TOWN OF BELGIUM, OZAUKEE COUNTY, WISCONSIN TO THE VILLAGE OF BELGIUM, OZAUKEE COUNTY, WISCONSIN

Whereas, on the 14th day of September, 1998, the Village Board of the Village of Belgium, adopted Ordinance No. 22-98 annexing certain territory in the Town of Belgium owned by Frederick E. Buechler and Cheryl M. Buechler; and

Whereas, a certified copy of said Ordinance No. 22-98 was recorded in the office of the Register of Deeds for Ozaukee County, Wisconsin, on September 29, 1998, in Volume 1125 of Records, Page 534, as Document No. 612837; and

Whereas, the Village of Belgium has subsequently determined that the Petition for Direct Annexation contained an error in the legal description of the territory to be annexed, which error was also contained in Ordinance No. 22-98; and

Whereas, it is therefore necessary to amend Ordinance No. 22-98 to reflect the correct legal description of the territory which was annexed thereby.

Now Therefore, Be It Ordained, by the Village Board of the Village of Belgium, Ozaukee County, Wisconsin, that Ordinance No. 22-98 be and hereby is amended to provide that the legal description of the territory annexed by the Village of Belgium by Ordinance No. 22-98 is as follows:

Being the northeast quarter of the southeast quarter and the north half of the southeast quarter of the southeast quarter of Section 22, T.12 N., R.22 E., Town of Belgium, Ozaukee County, Wisconsin, containing 60.25 acres of Land and being described as: Beginning at the East quarter corner of said Section 22; thence S. 1 degree 41' 39" E., 1985.41 feet along the east line said SE ¼; then S. 88 degrees 29' 23" W., thence 1320.87 feet along the north line of said ½ of the SE ¼ of the SE 1/4; thence N. 1 degree 43' 56" W., 1986.82 feet along the west line of said NE ¼ of the SE ¼; thence N. 88 degrees 33' 01" E., 1322.19 feet along the north line of said SE ¼ to the point of beginning.

The Village Clerk is hereby directed, pursuant to Section. 66.021(8)(a), Wis. Statutes, to file immediately with the Secretary of State a certified copy of this Ordinance, certificate and plat, and send one copy to each company that provides any utility service in the area annexed, and record the Ordinance with the Register of Deeds, and file a signed copy of the Ordinance with the clerk of any affected school district.

Be It Further Ordained, that the said annexed territory be, and the same hereby continues to be, designated for zoning purposes as follows: A-1, General Agricultural District.

This Ordinance shall become effective upon passage and posting.







