## A CHARTER ORDINANCE

## RELATING TO THE INCLUSION OF VILLAGE PERSONNEL UNDER THE WISCONSIN MUNICIPAL RETIRE-MENT FUND

The village board of the village of Maple Bluff do ordain as follows:

SECTION 1. Pursuant to section 66.90 of the Wisconsin statutes, the village of Maple Bluff hereby elects to include eligible village personnel under the provisions of the Wisconsin Municipal Retirement Fund in accordance with the terms thereof.

SECTION 2. Election is hereby made to provide prior service credits at rates equal to two times the rates of municipality oredits for current service, to be applicable to employees as defined by section 66.90 of the Wisconsin statutes who are employed by the village of Maple Bluff on the effective date of this ordinance.

SECTION 3. Upon the final enactment of this ordinance the village clerk shall submit a certified notice of the election made hereunder to the board of trustees of the Wisconsin Municipal Retirement Fund. Such notice of election shall (1) be in writing; (2) indicate the date and results of such election; (3) include a certification of the prior service contribution rate selected as being applicable to the employes of the municipality; (4) be officially certified by the clerk of the municipality.

SECTION 4. The effective date of participation shall be January 1, 1945.

SECTION 5. This is a charter ordinance and shall take effect 60 days after its passage and publication, unless within such 60 days a referendum petition shall be filed as provided by section 66.01 of the Misconsin statutes, in which event this ordinance shall not take effect until submitted to a referendum and approved by a majority of the electors voting thereon.
