Pursuant to Section 66.021 of the Wisconsin Statutes, and the petition for annexation filed with the Village Clerk by Dean Burrows and D.R. Burrows that certain territory be annexed to the Village of Holmen from the Town of Holland, LaCrosse County, Wisconsin by direct annexation as provided by Wisconsin Statute Section 66.021. THE VILLAGE BOARD OF THE VILLAGE OF HOLMEN, LACROSSE COUNTY, STATE OF WISCONSIN DOES HEREBY ORDAIN That the territory hereinafter described, and as shown on the scale map attached to this Ordinance, be annexed and made part of said Village of Holmen:

The NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 12, Township 17 North, Range 9 West, consisting of fourty(40) acres, all located in the Town of Holland, LaCrosse County, Wisconsin

The Village Board does hereby further ordain that the zoning classification of said annexed area shall be Agricultural "A", and shall be governed by the Holmen Zoning Ordinance.

Adopted and passed by unanimous vote of all Holmen Village Board members present for a regular meeting on August 9th, 1979.

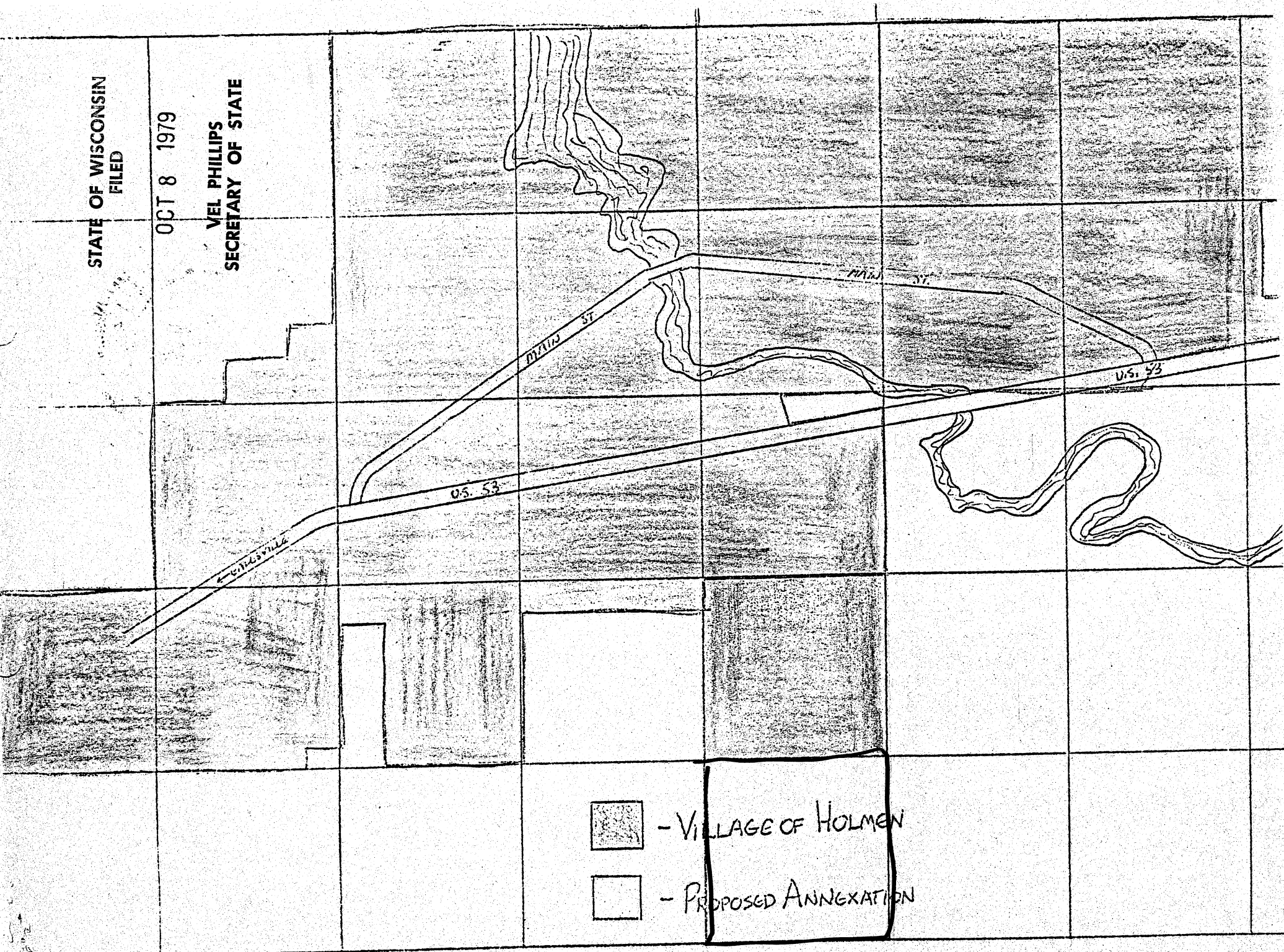
