Commencing at the center of Section 16, T13N, R6E; thence West 1327.2 feet more or less along the east-west quarter line of Section 16 to the point of beginning;

SW4-NW4 and the NW4-NW4 Section 27; thence continuing North along the east lines of the SW4-SW4, the NW4-SW4, the SW4-NW4 and the NW4-NW4 of Section 22 to the intersection of said east line with the southerly right-of-way of Canyon Road; thence Northeasterly along the southerly right-of-way line of Canyon Road to the south line of the SEA-SWA Section 15; thence East along the south line of the SEA-SWA to the southeast corner thereof; thence North along the east line of the SEA-SWA to the northeast corner thereof, said point also being the southwest corner of Government Lot 3; thence East along the south line of Government Lot 3 and the south line of Government Lot 3 extended to the center of C.T.H. "A"; thence Northwesterly along the centerline of C.T.H.
