ANNEXATION

ORDINANCE

The Village Board of the Village of Crivitz, Marinette County, Wisconsin, does ordain as follows:

1.) That the following described real estate and the same be and hereby is annexed to and made a part of the Village of Crivitz:

That part of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 27, Town 32 North, Range 20 East, Marinette County, Wisconsin, described as: Commencing at the North quarter corner of said Section 27; thence North 88° 26' 03" West along the North line of Section 27, 860.61 feet to a $\frac{1}{2}$ " iron rod on the West line of State Trunk Highway 141, said point being the place of beginning; thence continuing North 88° 26' 03" West along North section line, 200 feet; thence South 02° 53' 17" West and parallel with the West line of State Trunk Highway 141, 465 feet to a $\frac{1}{4}$ " iron pipe; thence South 88° 26' 03" East, parallel with the North section line, 200 feet to a $\frac{1}{4}$ " iron pipe on the West line of Highway 141; thence North 02° 53' 17" East along the West line of Highway 141, 465 feet to the place of beginning and containing 2.134 acres more or less.

2.) That this annexation shall be effective upon enactment of this ordinance.

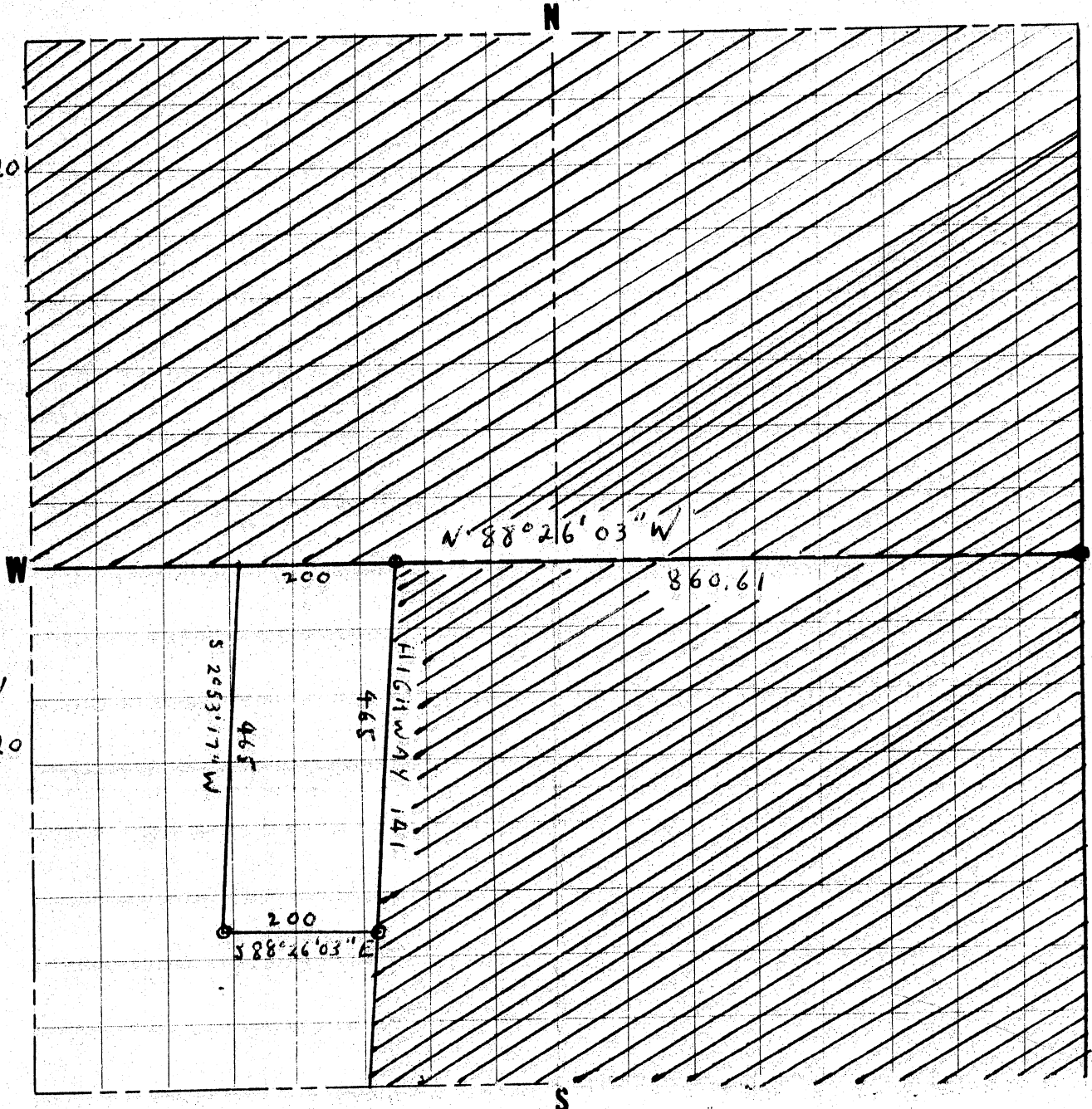

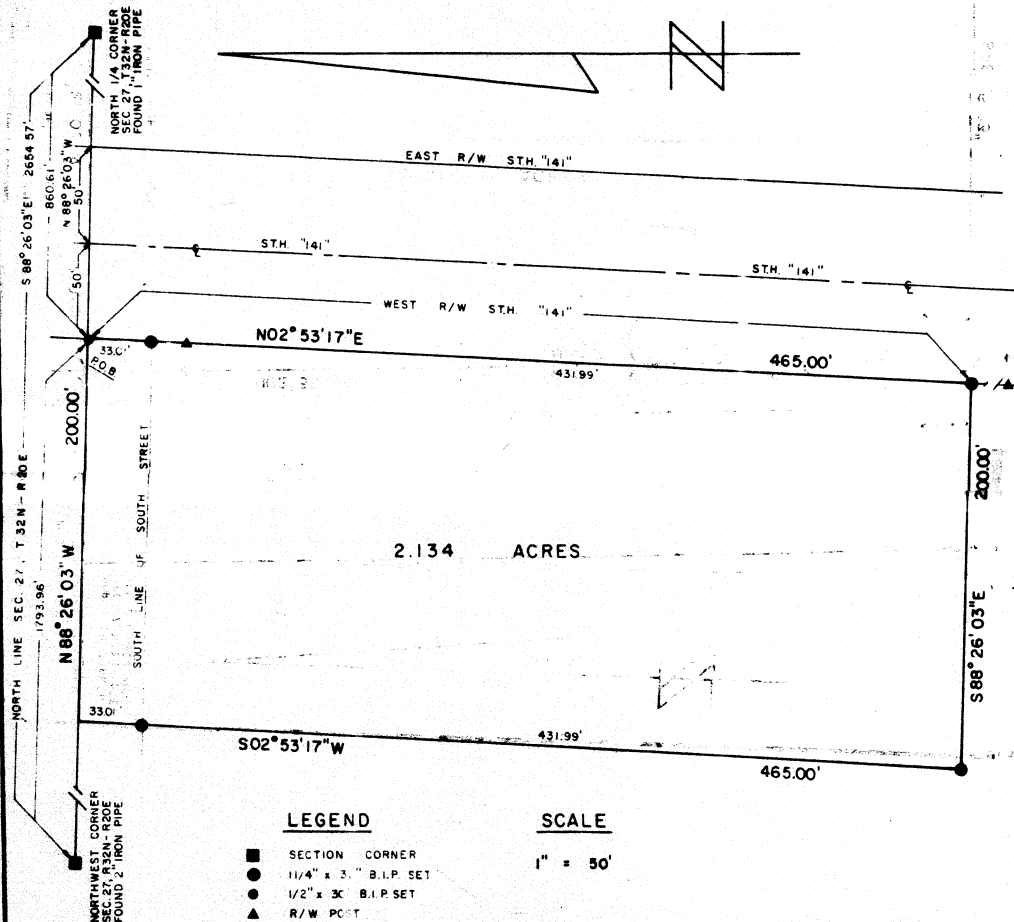
