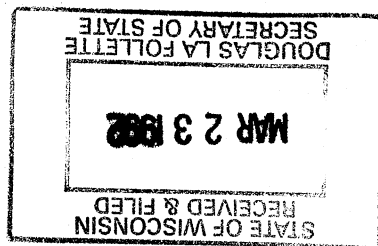

SEWER USER CHARGE SYSTEM

AN ORDINANCE AMENDING CHAPTER 7 ATTACHMENT A OF THE SEWER USER CHARGE SYSTEM AND PRESCRIBING INCREASED RATES FOR USERS OF THE VILLAGE OF CRIVITZ SEWER SYSTEM.

The Village of Crivitz Board of Trustees do hereby ordain that Ordinance Chapter 7 Attachment A Schedule 2 be hereby amended to read as follows:

Rates and Quarterly Minimum (Base) Charge:

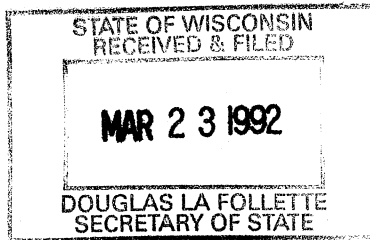
<u>Water Meter size</u>	<u>User Charge Factor RUE</u>	<u>Quarterly Base Charge</u>
5/8" or 3/4"	1.0	\$ 60.00
1"	1.5	\$ 90.00
1-1/4"	2.4	\$144.00
1-1/2"	3.3	\$193.00
2"	4.9	\$294.00
3"	10.9	\$654.00
4"	16	\$960.00

In addition, a charge of \$1.13 per one thousand metered gallons will be added to the quarterly base charge.

UNMETERED SEWER SERVICE: There shall be a penalty imposed upon any unit that does not have a sewer meter on a private well system. The penalty for this violation shall be computed by using an eleven thousand (11,000) gallon average quarterly consumption plus the base quarterly charge for the size water meter which would be the most appropriate under the applicable circumstances at the unmetered unit (to be determined by the Utility) and multiplying this number by two (2). Therefore the charge shall be as follows:

<u>Projected Meter Size</u>	<u>Quarterly Charge</u>
5/8" or 3/4"	\$144.86
1"	\$217.29
1-1/4"	\$312.86
1-1/2"	\$410.86
2"	\$612.86
3"	\$1332.86
4"	\$1944.86

The above rates shall be effective beginning March 1st, 1992 and shall remain in effect until this ordinance is repealed or amended.



This ordinance shall take effect and be in force upon its passage and publication as provided by law.
