I, Kenneth H, Weiss, City Clerk of the City of West Bend, County of Washington, do hereby certify that the following described territory was detatched from the Town of West Bend, County of Washington, and was annexed to the City of West Bend pursuant to Section 62.07 (3) Wisconsin Statutes, by ordinance hereinafter noted and at the regular meetings held on the dates hereinafter shown to wit:

Ordinance No. 467 passed January 14, 1952 That part of the NE_{4}^{1} of the SW_{4}^{1} of section 14, Township 11 North, Range 19 East, Washington County, Wisconsin, which is bounded by a line described as follows: Commencing at a point 282 feet west and 801 feet south of the center of said section and running thence South 70 feet, thence West 150 feet, thence North 70 feet, thence East 150 feet to the place of beginning.

Ordinance No. 471 passed June 9, 1952 That part of the NW_{4}^{1} of the NW_{4}^{1} of Section 14, Township 11 North, Range 19 East, Washington County, Wisconsin, described as follows: Commencing at a point in the north line of said section 14, said point being situated 617.25 feet east of the NW corner of said section 14, and running thence East along the north line of section 14, a distance of 120 feet, thence South 170 feet, thence West 120 feet, thence North 170 feet to the point of beginning.

Ordinance No. 475 passed July 14, 1952 That part of the $NW_{4}^{\frac{1}{4}}$ of the $NW_{4}^{\frac{1}{4}}$ of Section 14, Township 11 North, Range 19 East, Washington County, Wisconsin, which is bounded by a line described as follows: Commencing at a point in the north line of said Section 14, said point being situated 437.25 east of the NW corner of Section 14, and running thence East along the north line of Section 14, a distance of 180 feet, thence South 250 feet, thence West 180 feet, thence North 250 feet to the point of beginning.

post of Section 11: thence East on the south line of Section 11 to the common section corner of Sections 14,13,23, & 24; thence South on the section line between Sections 23 and 24 to a point 440 feet south of the NE corner of the SE¹/₄ of the NE¹/₄ of Section 23; thence West 250 feet; thence South 200 feet; thence East 250 feet to a point on said section line; thence South on said section line to the west quarter corner of Section 24; thence East on the east and west quarter line of Section 24, 396 feet; thence South 120 feet thence West 196 feet; thence South 140 feet; thence East 450.70 feet; thence South 40 feet, thence East on a line parallel to the east and west quarter line of Section 24 a distance of 1878.40 feet to a point in the westerly line of the C. & N,W. right-of-way; thence N 20° - 20' W along said right-of-way line 320.21 feet to a point in said east and west quarter line of Section 24; thence East to the center of Section 24; thence North along the north and south quarter line of Section 24 to the north quarter corner of said section; thence East 30 feet; thence North 220 feet; thence East 402 feet; thence South 220 feet; thence East 71.4 feet; thence North 220 feet; thence East to the easterly line of the west 60 acres of the SE4 of Section 13; thence North along said easterly line to a point in the east and west quarter line of Section 13; thence West along said east and west quarter line to the center of Section 13; thence North along the north and south quarter lines of Sections 13 and 12 to the center of Section 12; thence West along the east and west quarter lines of Sections 12 and 11 to a point 518.10 feet east of the center of U.S. Highway #45; thence North 21 feet; thence West to the center of said Highway; thence southwesterly along the center of said highway to the east and west quarterline of Section 11; thence West on said east and west quarter line to the southeast corner of the SW_{4}^{\pm} of the NE_{4}^{\pm} of said Section 11; thence North along the east line of said SW of the NE of Section 11, 776.28 feet; thence West to a point in the north and south quarter line of Section II; thence South on said north and south quarter line to a point 200 feet north of the center of said Section; thence West 160 feet; thence South 150 feet to a point 50 feet north of the east and west quarter line of Section 11; thence West on a line parallel to said east and west quarterline 345 feet; thence North 150 feet; thence West 50 feet; thence South 150 feet; thence West 476.5 feet; thence North 158.7 feet; thence West 64.5 feet; thence South 158.7 feet; thence North 158.7 feet; thence West 164.5 feet; thence S South 0.7 feet; thence West 188 feet; thence South 158 feet; thence West 1168 feet, to the west line of Section 11; thence South 50 feet to the place of beginning.




