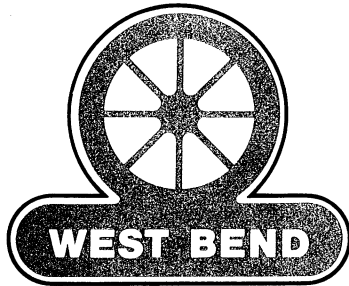

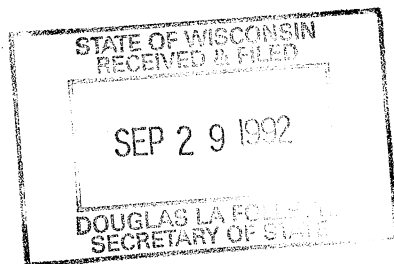

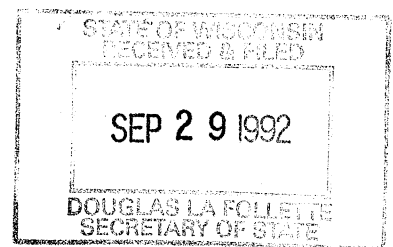

ORDINANCE NO. 2080
1992-1993 COMMON COUNCIL



An Ordinance to Annex to the City of West Bend,
Washington County, Wisconsin Property of
Washington County Youth Hockey Association

RECITALS:

- A. A Petition was filed with the City Clerk for the direct annexation, in accordance with Section 66.021 (12), Stats., of that part of the SE1/4 of the NE1/4 of Section 26, Township 11 North, Range 19 East, Town of West Bend, Washington County, Wisconsin, which is bounded and described as follows:
- Beginning at the E1/4 corner of said Section 26; thence N01°53'25"W along the section line 295.5 feet; thence S89°33'35"W, 225.00 feet; thence N59°36'54"W, 202.32 feet; thence S89°33'35"W, 135.99 feet; thence S00°19'35"E, 398.00 feet; thence N89°40'25"E along the east quarter section line, 543.00 feet to the place of beginning.
- B. A copy of the Petition for Direct Annexation and a scaled map of the territory proposed to be annexed were mailed to the Clerk of the Town of West Bend, and the Wisconsin Department of Development as required by subsection 66.021(11), Stats., as evidenced by the affidavit of Mailing on file with the City Clerk.
- C. Said Petition was referred to the City Plan Commission for recommendation concerning the Petitioners' request that said territory be assigned a temporary zoning classification of I-1 Institutional and Public Service District, and the Plan Commission did recommend such temporary zoning classification.
- D. The advice of the State of Wisconsin Department of Development concerning this annexation has been considered.
- E. Said Petition is signed by the owners of all of the land within such territory to be annexed.
- F. No person resides in the territory to be annexed.
- G. Said territory is adjacent to the boundaries of the City of West Bend.

Ordinance:

NOW, THEREFORE, the Common Council of the City of West Bend, Washington County, Wisconsin does ORDAIN as follows:

1. The above-described territory is annexed to the City of West Bend.

2. The above-described territory is annexed to the 24th Ward and is in the 4th Aldermanic District of the City of West Bend.
3. The annexation shall be effective upon enactment of this Annexation Ordinance by a two-thirds (2/3) vote of the Common Council and the publication of this Ordinance.

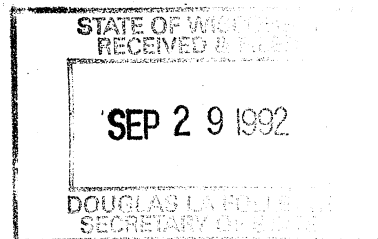

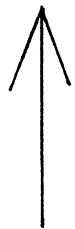
